


PROJECT: CYBERBULLYING AND HARASSMENT ON TIKTOK AND OTHER SOCIAL MEDIA PLATFORMS

- Blocking perpetrators on most social media sites will prevent them from viewing your profile or communicating with you in any way.
- Perpetrators must realise that their abuse will not stay anonymous. Virtually any cyberbullying can be traced back to the perpetrators.

It's also essential to seek emotional support if you're a victim of cyberbullying. Talk to a trusted friend or family member or seek professional counselling to help cope with the negative effects of cyberbullying. Additionally, victims of cyberbullying should consider seeking legal assistance to take appropriate action against the perpetrators.
