OUR CLIENT'S CASE:

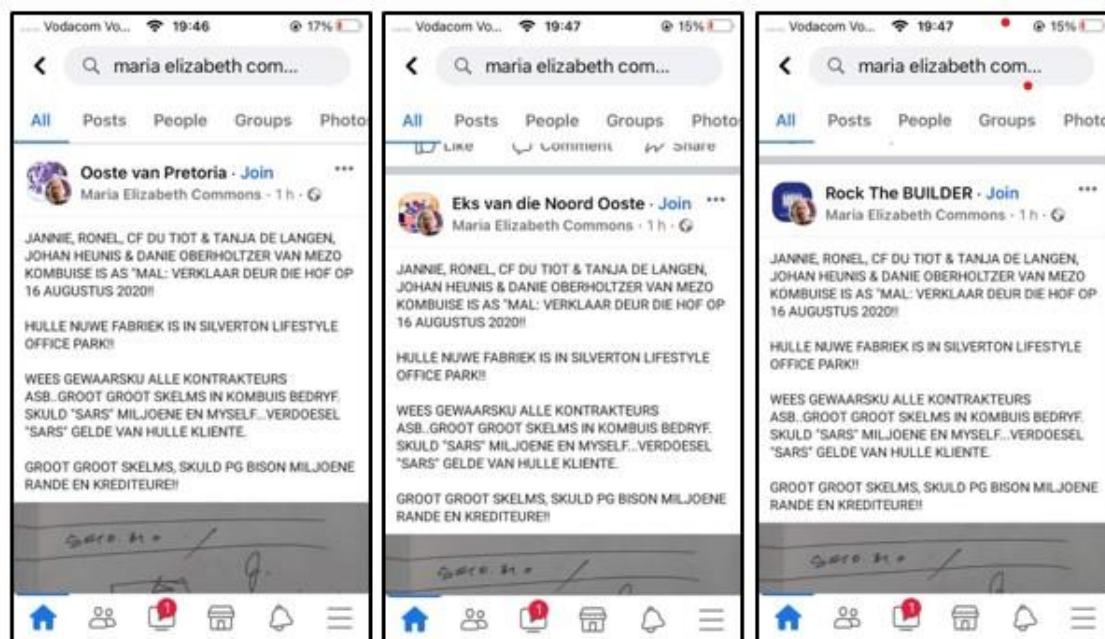
- Maria Commons' focus for the past 18 months has been to discredit a particular family.

 - Maria Commons
 - Maria E Commons
 - Maria Elizabeth Commons
 - Maria Commons (Marieks)
- She has accused this family of:
 - Owing her money.
 - Owing money to SARS.
 - Stealing deposits from the public.
 - Rape.
 - Possession of illegal firearms.
 - Driving with stolen vehicles.
 - Drug dealing.
 - Money Laundering.
 - Fraud.
- Ms Commons accuses the family of using toxic gas filtered through her car's ventilation system.
- She also believes that the family is tracking her through her car and cell phone.
- She believes that the family is communicating with her through some device that seems to be planted in her throat.

The slanderous lies spread on social media and the continuous harassment by Ms Commons has caused the family emotional humiliation and trauma, financial losses, and reputational devastation.

Ms Commons' deliberate intent is to maliciously defame and ruin this family.
