Her father was arrested this weekend for helping with the escape plan.

The delegation from South Africa in Tanzania is still awaiting a decision from Tanzania authorities if Thabo Bester and Nandipha Magudumana will be deported or extradited.

# WATCH THE LATEST INTERVIEW ON NEWS CENTRAL ON 11 APRIL 2023 WITH MR MIKE BOLHUIS:



### DR NANDIPHA MAGUDUMANA:

- Dr Nandipha Magudumana **stole 3** unidentified bodies from state and privately-owned morques in the Free State.
- The 1st body she claimed to be her husband, which is the body found in Thabo Bester's cell.
- The 2nd body she claimed to be her father was found a week later in a river in the Bloemspruit area, also in the Free State.
- The 3rd body is still missing.
- Some bodies were identified from a catalogue and some in person by Dr Nandipha Magudumana.

### THE OTHER PRISONERS INVOLVED:

- Two prisoners saw Thabo Bester leave in a DCS uniform with a high-ranking official.
- G4S replied to their emails with "no complaint to be captured" and told the prisoners to write letters to the following people, which they did:
  - President Ramaphosa.
  - o Justice Minister Lamola.
  - Judge Cameron.
- In October last year, after receiving a letter from a prisoner, Judge Cameron sent investigators from the Judicial Inspectorate for Correctional Services (JICS) to investigate.
- The prisoners were then moved to another prison for their own safety.
- A previous employer of G4S was arrested this weekend.

# PRISON WARDERS AND SAFETY AND SECURITY AUTHORITIES:

- A former prison warder Senohe Matsoara was arrested and is being charged with murder, arson, fraud and defeating the ends of justice.
- His bail application was postponed until next week.

### DR NANDIPHA MAGUDUMANA'S FATHER:

- Zolile Cornelius Sekelani, was also arrested this weekend for helping with the escape plan.
- Zolile Sekeleni is being charged with murder, arson, fraud and defeating the ends of justice.
- His bail application was postponed until next week.

### THABO BESTER:

- He applied to be transferred to a single cell 2 weeks before his escape, but this request was denied.
- On the day of his escape, he was suddenly moved to a single cell.
