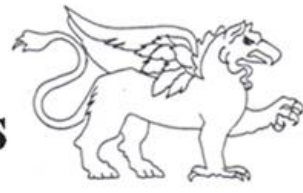

## **IDENTITY:**

- Police Minister Bheki Cele confirmed that Thabo Bester's identity was confirmed with fingerprints from previous arrests and sentencing.
- These fingerprints were also used in the deportation of Thabo from Tanzania back to South Africa.

## **ARRESTS MADE:**

- Dr Nandipha Magudumana.
- Her father, Mr Sekeleni.
- Former prison warder, Mr Motsoara.
- A CCTV Technician working at Mangaung prison-Mr Lipholo.
- A Current G4S employer, Mr Motayane Masukela.

## **"GETAWAYS":**

- Thabo Bester and Nandipha Magudumana enjoyed "getaways" together while he was supposedly in prison.
- They stayed at the Tredenham Boutique Hotel in Bloemfontein for five nights in March 2022 and again for one night in April.
- The booking was made in the name of TK Nkwana.
- Three weeks after the last "getaway" together he escaped from prison.
- Justice Minister Ronald Lamola said that he only became aware of this in late March 2023.

## **BODIES CLAIMED/STOLEN:**

- Dr Nandipha Magudumana stole 3 unidentified bodies from state and private morgues in Bloemfontein.
- The 1<sup>st</sup> body she claimed, Dr Magudumana insisted was the body of her father.
  - A week later, this body was found in a river near Mangaung prison with the tag still attached to the toe.
- The 2<sup>nd</sup> body she claimed, she said was that of a friend's brother.
  - This body is still unaccounted for.
- The 3<sup>rd</sup> body she claimed, she said was that of her common-law husband.
  - This body was found in cell 35 at Mangaung Prison.
  - This was also the body she claimed in person after the escape, saying it was Thabo Bester, her common-law husband.
- One of the bodies she stole was taken by means of an affidavit signed in Polokwane.
- The SAPS member who signed the affidavit in Polokwane has been suspended pending further investigation.
