- "Iron" started creating a new scam where she claimed to be the victim of cyberbullying, and once again, people would send her money to show love and support.

- In mid-April 2023, "Iron" went on a "live" with another TikTok person who pushed her to admit that she was lying about everything and needed to come clean with the truth.
 - On the same "live," "Iron" started screaming hysterically and ended the stream.
 - She then arranged with her mother to send a voice note the next day stating that "Bianca" had committed suicide using a black bag over her head and was found dead by another well-known TikTok influencer.
 - The entire TikTok community was shocked and mourned the loss of "Iron," aka Bianca.
 - A few days later, the very same person who devised this twisted plot was caught on a "live."
 - It has been confirmed by various well-known TikTok influencers that "Iron," aka "Bianca," had fooled a lot of people and scammed them out of their money.

The comments and theories of South African influencers and their followers on TikTok are rife. It changes and escalates on an hourly basis. To date, there is an enormous amount of slander, defamation, and hate speech.

THE SSS INVESTIGATION:

- SSS can confirm that there was no suicide.
