Johan (Eddie) Rabe and Eckard Rabe.**

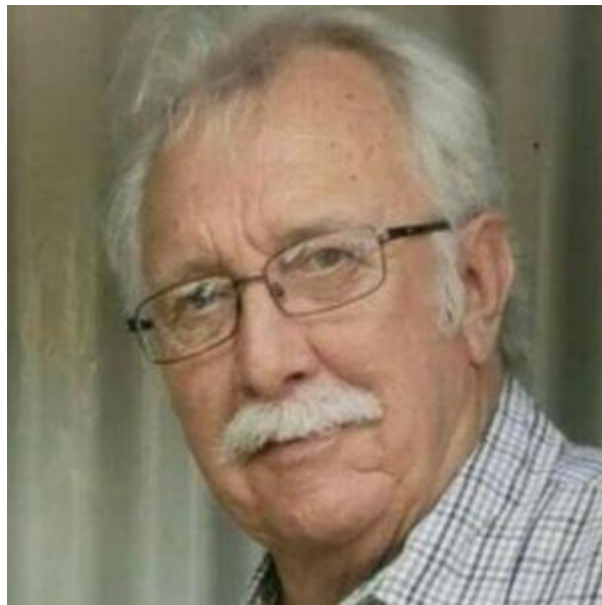
