


# PROJECT: NEW DSTV SERIES COLD BLOOD (EPISODE 3) THE MURDER CASES OF MIKE BOLHUIS

cold cases in South Africa.

The lifeless body of Yolandi Botes, a mother of three, was found in the Vaal River by a grandfather and his grandson on 4 May 2021 after she had been reported missing on 26 April 2021.

As her body had been dismembered. The only way she could be identified was by the tattoo on her forearm:

"Wietzue 11.09.2019"

her husband's name - and their wedding date.

Two years after Yolandi's death, we still don't know who killed her or what happened that day. This hard-hitting investigation series follows Mike Bolhuis' relentless pursuit of a person or individuals responsible for her death - who are still on the loose.

"My daily experiences in fighting crime in this country are often shocking, and the cases I see are often horrifying.

Nevertheless, the murder of Yolandi Botes is one of the most notable in my experience. Re-investigating was necessary to ensure that all evidence is considered to bring the guilty to justice and to provide closure for Yolandi's family," says lead investigator, Mike Bolhuis.
