



SUCCESS PROJECT: KNOCKS AND SCAMS ORCHESTRATED FROM SOUTH AFRICAN PRISONS

Specialised Security Services has previously exposed the severe conditions experienced by prisoners in South African prisons:

It is worth noting that some of these prisoners are unscrupulous businessmen and remorseless scammers who continue to conduct their business affairs while serving their sentences.

Recently, Mr Bolhuis and his team were tasked with locating an inmate engaging in fraudulent activities while incarcerated.

- Joseph Nquru, a prisoner, has been caught red-handed scamming over 30 people out of hundreds of thousands of rands.
- His modus operandi involved posing as a purchaser of stock and farms.
- However, he was apprehended with multiple credit cards and a cell phone.

- This incident is a grave reminder of the severity of such scams and underscores the urgent need for effective security measures, such as cell phone signal jammers, within correctional facilities.
 - The investigation into Nquru's operation was spearheaded by Mr Mike Bolhuis and his team of experts in serious and violent crime, who assisted the SAPS in tracking Nquru to his prison cell.
 - The investigation aims to unearth how Nquru was able to conduct his activities from within his cell, including forging papers and impersonating a wealthy sheep farmer using the identity of a previous victim.
 - In addition, it has been reported that Nquru was able to forge documents and papers from his prison cell, which he then used to further his criminal activities.
 - Nquru sent these forged documents and fake proof of payment to a real estate company to scam them.
 - It is unclear how he was able to obtain the materials needed to forge these documents.

Bewys van plaas oorbetalings is gedoen, asook 'n addisionele bedrag vir die aankoop van Bonsmara beeste wat op die plaas afgelaai moet word. Dit is hier waar dit nou bietjie ingewikkeld raak om so per whatsapp te probeer verduidelik. Die kort weergawe is: 1. Ons is gescam met R160 000 (wat ons solank voorgeskiet het vir die aankoop van die beeste. 2. Die scammer wat hom voordoen as Mnr JJ Pieterse het die regte Mnr JJ Pieterse ook bedrieg om sodoende al sy dokumente in die hande te kry. Ons is nog in gesprek met die scammer per whatsapp en benodig nou dringend hulp - dalk kan sy selfoon nog getrace word. Asseblief kan ek dringend met jou gesels? Hy het blykaar reeds 6 mense so gevang.

- The discovery of an undocumented inmate running a scam operation from within Mangaung Correctional Centre is unacceptable and highlights the alarming security vulnerabilities within South African prisons.
 - Immediate action must be taken to invest in robust security measures and implement ongoing monitoring of inmates.
 - It is imperative to thoroughly investigate how these operations are conducted from within cells and take decisive measures to prevent future occurrences.
 - While inmates may be granted internet access for educational purposes, it is imperative that cybersecurity measures are prioritized to ensure the safety of all involved.
