- Because of Michelle's sincere remorse and her comprehensive confession, SSS will give her the benefit of the doubt and will protect Michelle and her family.
- Our request to the TikTok community is to stop the relentless prosecution of Michelle Spies Terblanche and to commit to order and positive collaboration.
- Any form of victimisation, intimidation, threats or bullying will not be tolerated.
- Our interest in this case, was and is to inform and warn the public:
  - Crime is rampant on all social media.
  - Stay vigilant and beware of any person who asks for money.
  - Always do thorough vetting before believing anyone or buying anything that is advertised.
