- The project involves our client Mr André Smith, who had a private trailer built by Mornè Pienaar.
 - Upon receiving and towing the trailer, Mr Smith noticed some mechanical issues.
 - Mornè agreed to repair the trailer, and his wife Letitia picked it up from our client to take it to their workplace for the repairs.

- Unfortunately, Mornè and Letitia were unresponsive to inquiries about the trailer, causing Mr Smith to contact Mr Bolhuis.
 - Mr Bolhuis tasked Specialist Investigator, Mr Jacques Visser to resolve the complaint from our client.
 - Mornè Pienaar eventually responded and expressed his desire to settle the matter.
 - However, there were instances when he did not answer his phone.
 - When his wife was contacted, Letitia revealed that Mornè had fled to Richards Bay, and she did not have his address.
 - She also mentioned that she and Mornè were getting divorced and did not know what happened to the trailer.
 - Due to this situation, the client opened a criminal case of theft with the SAPS: CAS 14/04/2022.
 - The case was transferred to the Vehicle Branch, where the Detective in charge stated that he cannot find Mornè and that Letitia is not giving her co-operation.
 - Neither Mornè nor Letitia are answering any calls from the SAPS or SSS Investigating Officers.

*Both Mornè and Letitia Pienaar are
wanted for theft of the trailer.*

*They live in the Pretoria area and according to
an informant of SSS, Mornè Pienaar was seen
in the vicinity of John Vorster Technical High
School in the Pretoria Moot area.*
