- If you perform private investigations, you must, according to Section 21 of the Private Security Industry Regulation Act, 2001 (Act No. 56 of 2001), register as a Security Service Provider. You must be a Grade A registered provider.
- "Dr" Cromhout's application was rejected and therefore, he is not registered to perform any private investigations or other security services.

- This is an International Institution of Higher e-Learning.
