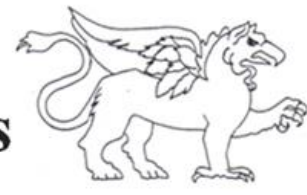

PUBLIC WARNING!

Specialised Security Services, the leading security company in South Africa, issues a public warning today regarding a dangerous scammer - Anro Dias - who has been defrauding multiple individuals in the Pretoria and surrounding areas.

Mr Dias, a 29-year-old resident, has been posing as an investigator from Specialised Security Services, preying on innocent people by offering assistance in investigating cybercrime cases.

It is essential for the public to be aware of this impersonator and exercise caution to avoid falling victim to his fraudulent activities.

This exposure project serves two purposes:

1. To warn the public against the con-artistry of Mr Dias – he is an absolute misrepresentator, a fraud and a thief.

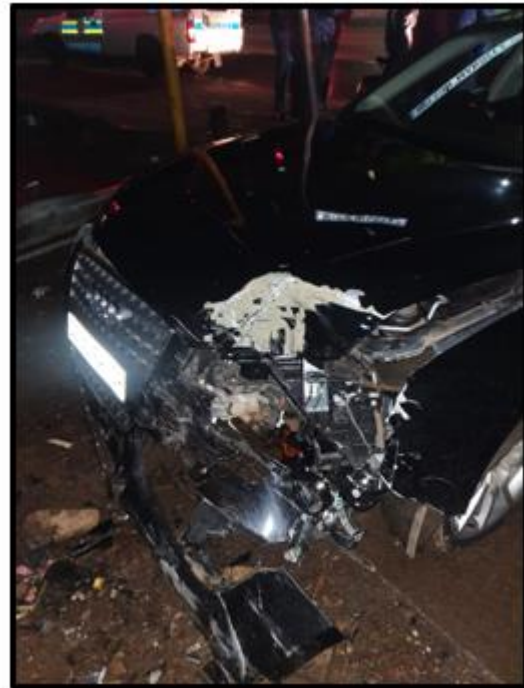

 - He purports to be a Christian.
 - He tells stories of his newborn baby son and his other children.
- Anro Dias steals the information of a company, then extorts the same company, using their own information against them.
- He uses the good name and reputation of Mr Bolhuis and his company Specialised Security Services, to gain credibility.
- He also uses the names of high-ranking SAPS officials and HAWKS' members for the same advantage.
- We are convinced that Anro Dias has been committing this type of crime for the last couple of years.

- He has stated to various clients that he works for Mr Bolhuis and Specialised Security Services as a specialist cybercrime investigator.
 - By affiliating himself with SSS, the SAPS and the HAWKS, Mr Dias manipulates his victims and moves them to trust him, pay him and hand over expensive electronic ware (cell phones, laptops, etc.) and even motor vehicles.
 - Mr Dias sells these devices for cash.
 - He has also taken motor vehicles as a deposit from his clients.
 - In one scenario, he persuaded a client to buy an Audi.
 - The client soon realised that the vehicle was not registered in her name but in the name of Anro Dias.
 - Mr Dias went even further and took cell phones and laptops from this client.
 - The total loss suffered by this unsuspecting client is in the region of R150,000.00.
 - It was not long afterward, that Anro Dias totally wrecked the Audi in an accident.
 - The car is a complete write-off.



- SSS is aware of 2 other clients who have lost R150,000.00 and R81,000.00 respectively.
- One of the bank accounts, he uses:
 - Bank: FNB/RMB
 - Account Holder: Anro Dias
 - Account Type: Savings Account
 - Account Number: 63029451159
 - Branch Code: 250655
- He promises extraordinary services and solutions that he can render with regard to digital and electronic investigations.

- He purports to be an exceptional specialist in cybercrime investigations.
 - SSS HAS IDENTIFIED THAT THIS IS NOT THE CASE.
 - In the meantime, SSS has brought Mr Anro Dias in and he has since admitted to these fraudulent crimes.
 - Mr Bolhuis ordered and received professional polygraphs to verify his admissions and statements.
 - Although SSS has confiscated all electronics from Mr Dias, it is important that we are notified whether anyone else has been a victim of his fraudulent activities.
 - SSS will open criminal cases against Anro Dias in an effort to assist other complainants.
 - All the information and facts retrieved by SSS will be readily available to the SAPS and the HAWKS to compile a detailed and complete case against Anro Dias.

- Anro Dias is well-known for his manipulative tactics, playing on his targets' emotions, paranoia, and vulnerabilities.
- He promotes himself by saying that he specialises in crypto recovery and other cybercrime investigations.
- By pretending to work under the direction of the Hawks and claiming to be a specialised investigator for SSS, he gains the trust of unsuspecting individuals.
- SSS wants to make it unequivocally clear that Anro Dias has no affiliation with Specialised Security Services, nor is he authorised to represent our organisation in any capacity.
- We strongly condemn such fraudulent behaviour and are taking immediate action to ensure that Mr Dias is held accountable for his crimes.
- We have reported the matter to the South African Police Service (SAPS), and a case has been registered with the SAPS under the case number NORKEMPARK CAS 59/6/2023.
- Another case has been opened against Mr Dias: CULLINAN CAS 74/6/2023.
- We encourage anyone who has fallen victim to Anro Dias' scams or possesses information related to his activities to come forward and cooperate fully with the authorities.
- By working together, we can bring this criminal to justice and protect others from becoming his next victims.

- At Specialised Security Services, we pride ourselves on maintaining the highest level of professionalism and integrity.

- We have strict protocols in place to ensure the safety and security of our clients. It deeply concerns us when individuals like Anro Dias exploit the trust people place in our organization.
 - Rest assured - we are working closely with law enforcement agencies to ensure that the actions of fraudsters do not tarnish our good name and reputation.
 - In light of these events, we strongly advise the public to exercise caution and verify the credentials of anyone claiming to represent SSS or any other legitimate organisation.
 - Do not engage in any financial transactions or disclose personal information to individuals without proper identification or verification.
 - If you suspect any fraudulent activity, it is crucial to report it to your local law enforcement agency immediately.
 - Cybercrime is an extremely specialised field and once you are involved in criminal cybercrime activities for personal financial gain, it is very difficult to stop.
 - SSS however will relentlessly pursue Mr Dias, and do everything in our power to apprehend him, stop him and recover money lost.
