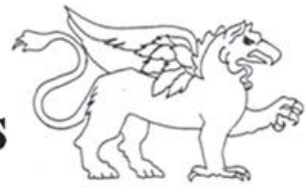

If you spot puppies being sold on the roadside, please report it to the nearest police station immediately.

It's crucial not to buy these puppies, even if you feel compelled to do so.

*These puppies are bred at nearby
squatter camps. They have not been
vaccinated or dewormed.*

- Backyard breeders, puppy mills and pet shops have created one of the most serious problems facing animal rescue organisations because they have tapped into a very lucrative market: sympathetic animal lovers.
 - By buying these puppies, you are advancing this market for animals.
 - It creates a market for unscrupulous breeders, and they simply keep doing what they're doing – namely, breeding animals in terrible conditions.
 - If no one buys these animals, there will be no business for puppy mills and pet shops, and their revenue stream will dry up.
 - While these sellers realise that money can be made in this way, they will continue breeding the animals.
 - Roadside puppies can carry a variety of infectious diseases such as mange and diarrhoea.

- They can also be contaminated with the deadly Parvovirus or distemper, endangering your own pets at home.
 - Many of these animals, when unsold become neglected or abandoned.
 - Most of these “rescued” animals end up at shelters, which are already overcrowded, starved of funding and struggling to home the animals they already have.
 - Instead, adopt a dog or any other animal at your nearest SPCA.
 - An adoption fee will cover the cost of the necessary vaccinations, deworming microchip and sterilization
 - These animals have had the necessary injections and have been sterilised and tagged/microchipped.
