

# PROJECT: WANTED JACO SWART GENDER-BASED VIOLENCE AND DOMESTIC VIOLENCE

Mr Mike Bolhuis is well-known for his passionate involvement in helping the most vulnerable of society, women, children and the elderly, and for his endeavours in eradicating violent crimes committed against them.

- Jaco Swart gained notoriety and the wrath of South Africans as social media exploded with video footage of how he viciously attacked, hit and kicked his wife.
- After the incident made headlines, he fled, fearing for his life.
- The thirty-nine-year-old Swart was fined just R20 000 for this hideous attack on his wife and he received a suspended sentence.
- Afriforum has successfully applied for a new summons instructing Mr Swart to appear in court on 14 August 2023 for assault with the intent to do grievous bodily harm to a SAPS female police officer:
