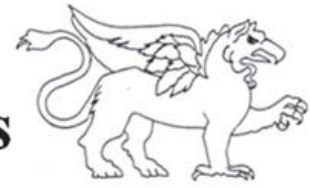

  - After numerous meetings and conversations with Mr White in August 2022, our client entrusted him with jewellery, including certificates, to sell in the UK.
  - Additionally, our client gave Mr White a single earring piece and requested that he create a matching one as she had lost it.
  - He provided a quote of R4,000.00, which she paid into his FNB bank account.
  - Mr White informed our client that he regularly attends jewellery auctions in the UK and promised to assist her in obtaining the best possible price.

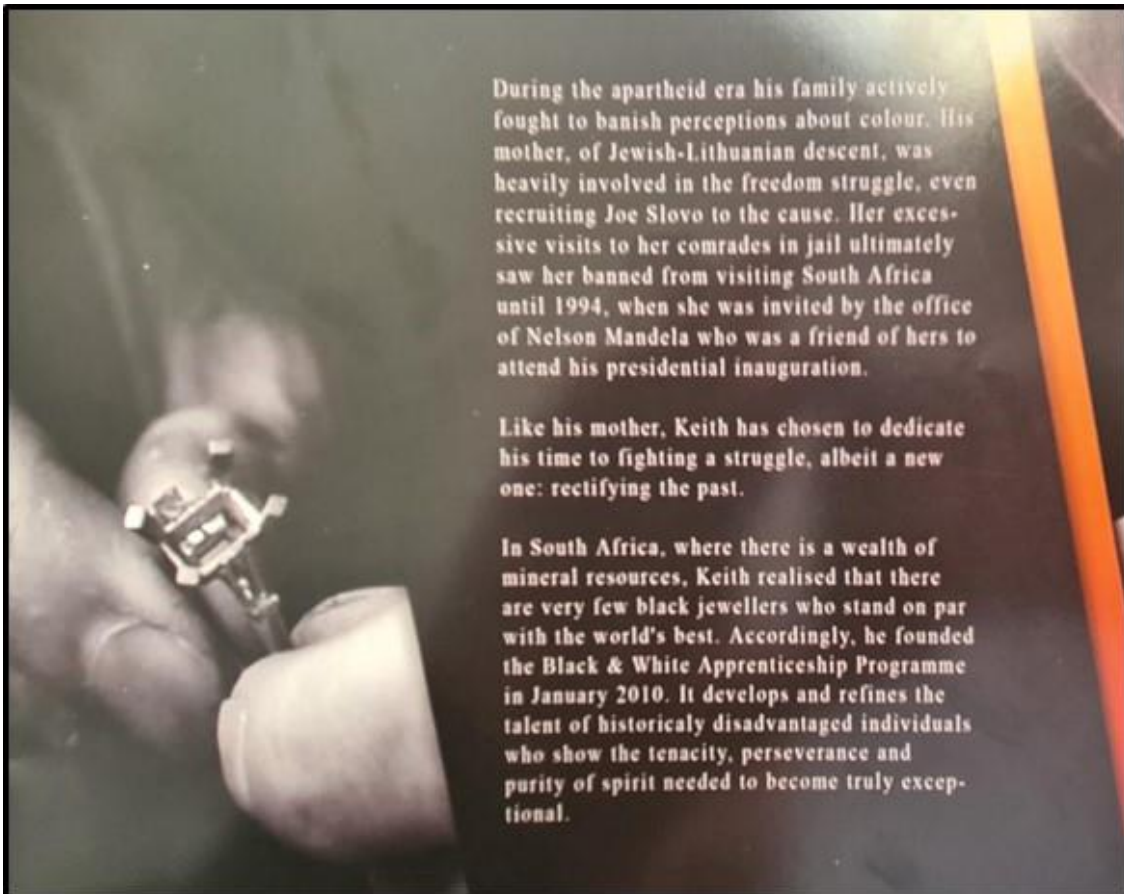
## JEWELLERY THAT WAS TAKEN BY MR WHITE AND NEVER RETURNED:

## NEW INFORMATION:

- According to friends and colleagues we spoke to, Mr White divorced his wife and relocated to the UK.
  - Mr White has scammed numerous people.
  - Mr White presents himself as someone whose family had significant involvement in the freedom struggle, even claiming to have recruited Mr Joe Slovo to the cause.
  - His mother was banished from South Africa due to her activities during the apartheid struggle and only returned to the country in 1994, where she was invited to the Presidential inauguration of President Nelson Mandela.
  - Additionally, in 2010, Mr White initiated a program called the "Black & White Apprenticeship Programme" aimed at nurturing young, aspiring Black jewellery assistants.
