*22-Year-old Miss Odendal went missing in March 2023 from her home in Mpumalanga. Miss Odendal is expecting a baby. It was suspected that she left with her partner to his home in Rayton.*

---

*She never returned home.*

*SSS specialist investigator, Mr Jan Roos was contacted by a member of the public informing him that Miss Odendal was seen in Sunnyside, Pretoria, on Tuesday, 20 June 2023.*

---

- A nationwide search was launched for Miss Odendal and her partner.
  - On 20 June 2023, specialist investigator Mr Roos received information that she was in Sunnyside, Pretoria.
  - Mr Bolhuis was contacted by a family member of Miss Odendal and asked if SSS could immediately assist as they were extremely worried about Miss Odendal's safety.
  - When Mr Roos reached the address of Miss Odendal's temporary residence, cooperating MACS-motorcycle members were present with officials of Metro Police.
  - As the concerned parties were waiting with Miss Odendal for officials of Welfare Services, her boyfriend returned.
  - Since he was excessively aggressive, the Metro Police members had to remove him and place him in holding.
  - According to information received the boyfriend was planning to sell Miss Odendal and her unborn child to an occult group.
  - Miss Odendal later started showing withdrawal symptoms.
  - She admitted that she was using crystal meth.
  - At this stage, she also declined to open cases against her boyfriend.
  - Mr Roos and the rest of the SSS specialist investigators then decided after consultation with Mr Mike Bolhuis, to take Miss Odendal to a rehabilitation centre.
  - At this time, Miss Odendal and her unborn baby are safe.
