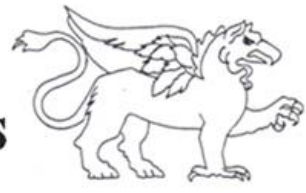

CASES:

- Mr X bought a caravan from Mrs Y and Mr Engelbrecht said he would facilitate the finance.
- Mr X paid a deposit of R300,000.00 to Mr Engelbrecht.
- Mr Engelbrecht told Mr X that he would finance the difference of R150,000.00.
- Mr Engelbrecht sent proof of payment to Mrs Y for R450,000.00, which turned out to be false.
- Mr Engelbrecht also took a jet ski from Mr X to sell for R160,000.00.
- Mr Engelbrecht sold the jet ski to Mr Y.
- No money was paid to Mr X for the jet ski.
- SAPS cases opened:
 - Garsfontein CAS 289/04/2023.
 - Garsfontein CAS 399/04/2023.

ARREST/BAIL:

- Mr Engelbrecht was arrested on 9 June 2023 by Garsfontein SAPS detectives and appeared in court on Monday 12 June 2023.
 - Bail was set at R3000-00.
 - Mr Engelbrecht paid bail on 29 June 2023 and was released.
 - Applicable cases to this bail application:

- The SAPS is still investigating the following fraud cases against Mr Engelbrecht:

MODUS OPERANDI:

- Mr Engelbrecht enters into agreements with the complainants to avoid criminal cases from being opened against him.
 - He signs Acknowledgment of Debt Agreements to appease the clients.
 - He then makes irregular payments or just stops paying altogether toward these AODs.

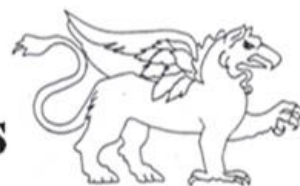
