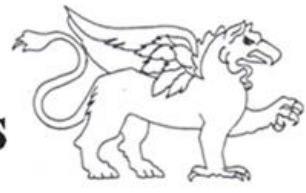

*Mr Tyrone Venter and Mrs Chanè Venter are wanted on various cases, but with this project, SSS was mandated to ascertain more information regarding their fraudulent "ride to own" concept.*

## **MODUS OPERANDI:**

- The couple entices innocent members of the public with what is known as a fraudulent scam called "ride to own".
- They sell vehicles ceded to banks.
- They do not have the registration papers of these vehicles as the banks are the legitimate owners.
- They obtain the vehicles from people who are in financial crises, seeking others to take over the monthly instalments.
- They would pay commission to people who refer others to them.
- It is frustratingly impossible to open criminal cases against this couple as the clients are in the wrong - you are not allowed to breach your contract with the bank financing your vehicle.
- You cannot basically sell any vehicle by having someone else make the payments on your behalf.
- The couple would blatantly take a car back from someone who has paid a deposit and who has been making payments for several months.
- They would then "resell" the same car to someone else: asking for a deposit and having them pay monthly instalments.
- It is known that the couple is currently in Mozambique, where they own a resort.

## **EXAMPLE CASE:**

- Tyrone and Charnè Venter entice representatives by promising an above-average income.
- Tyrone explains the process by claiming he has helped many other people in similar financial desperation.

## **THE "RIDE-TO-OWN" PROCESS:**

- The new representative must finance a vehicle in their own personal name.
- Tyrone then finds customers to "rent" this vehicle from the representative.
- Tyrone Venter promises to pay the representative an amount "in good faith" when he finds a customer for the vehicle.
- A "Tracker" is installed by his company, ensuring that they are able to collect the vehicle should the new customer miss or stop paying the monthly instalments.
- Tyrone Venter persuades the representatives that the more expensive their vehicle is, the more they will receive when he pays their initial "in good faith" money.
- Tyrone pays this amount to sweeten the deal even before he takes the newly financed vehicle.
- He then advises the representative to use his "own" insurance through his company as they are already paying and installing the "Tracker".
- A few months later Tyrone Venter started having difficulties collecting the "rental" customers' monthly installments.

- He uses various excuses, telling our client that the person who "rented" the vehicle is in prison.
  - Therefore he is unable to either collect the instalments or the vehicle itself.
  - He then pays an amount over to subdue the representative, although this person (our client) is already in arrears with 2 premiums.
  - No further payments were made to our client.
  - At this stage, our client started receiving messages, threatening him and his family that he would report them for defamation if they were to expose him on social media.
  - Furthermore, he said that he would not allow anyone to comment negatively on himself or his company as this means he would lose clients.
  - Our client was also told that they could not cancel the agreement with Tyrone Venter, as they would have to refund Tyrone "fees" of approximately R80,000.00.
  - Eventually, the representatives either forfeit their financed vehicles or borrow money to repay the outstanding instalments.
