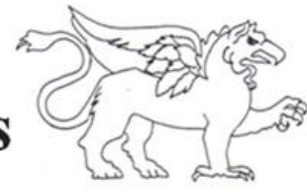

OF SAPS MEMBERS

In recent years, South Africa has been grappling with a distressing trend-the alarming increase of targeted violence against police officers. These dedicated individuals, who put their lives on the line to uphold law and order, find themselves becoming victims of heinous crimes.

SSS has addressed this issue on several occasions and our concerns are mounting.

This project aims to shed light on the most recent statistics of murders of South African police officers and delves into the underlying factors contributing to this targeted violence.

RECENT STATISTICS:

- The most recent statistics paint a grim picture of violence faced by South African police officers.
- While precise data may vary, it is evident that the number of officers losing their lives in the line of duty has been rising steadily.
- According to available information, it was reported that 58 police officers were killed between April 2020 and March 2021 alone.
- It is essential to note that statistics are subject to change.
- POPCRU, Police and Prisons Civil Rights Union, have stated that since the beginning of 2023, thirteen officers were killed and several more were left with career-threatening injuries, leaving members of the police force fearing for their safety.

- South Africa is plagued by high poverty levels, income inequality, unemployment, and social dislocation.

ORGANISED CRIME:

- South Africa also faces significant challenges related to organized crime, including drug trafficking, illegal firearms trade, and gang activities.
- These criminal networks view law enforcement as an obstacle to their operations and seek to eliminate those who stand in their way.
- Police officers, are front-line defenders against these criminal elements, and become prime targets for those seeking to protect their illicit activities.

CORRUPTION AND INTERNAL THREATS:

- Another factor that cannot be overlooked is the issue of corruption in South African law enforcement agencies.
- Instances of police officers colluding with criminal elements or engaging in unlawful activities erode public trust and lead to resentment among the population.
- Such internal threats compromise the effectiveness of the police service and put honest officers at greater risk, as they may be seen as traitors by both criminals and their colleagues.

SOCIETAL TENSIONS AND PUBLIC PERCEPTION:
