PROJECT:
RISKS OF TIKTOK

TikTok, a popular social media platform, has garnered significant popularity worldwide, including in South Africa. While offering a diverse range of entertainment and creative opportunities, concerns have emerged regarding the potential risks associated with its usage.

This project aims to shed light on the dangers posed by TikTok in South Africa, focusing on various aspects that require attention.

Additionally, we will explore TikTok's community guidelines, which serve as a framework to promote user safety and mitigate these risks effectively.

THE RISKS OF TIKTOK IN SOUTH AFRICA:

CYBERBULLYING AND ONLINE HARASSMENT:

- TikTok's extensive user base exposes individuals, especially young users, to an increased risk of cyberbullying and online harassment.
- The ease of anonymous commenting on videos can lead to hurtful and abusive behaviour, negatively impacting users' mental well-being.
- Reports of Cyberbullying Incidents in South Africa:
 - In March 2022, a teenager in South Africa became a victim of cyberbullying on TikTok, enduring derogatory comments and abusive behaviour from other users.
 - This incident severely impacted the teenager's mental health, necessitating intervention from parents and school authorities.

INAPPROPRIATE CONTENT:

- TikTok's algorithm-driven content recommendation system occasionally exposes users, including minors, to inappropriate and explicit content.
- Despite efforts to filter such content, encountering material unsuitable for specific age groups has been reported.

PRIVACY CONCERNS:

- The collection and handling of personal data on TikTok raise concerns about user privacy.
- Allegations suggest that user data, including location information and browsing habits, has been shared with third parties without proper consent, potentially compromising user privacy and security.

ONLINE PREDATORS:

- TikTok's accessibility and popularity make it an attractive platform for online predators who may engage in grooming behaviours or exploit vulnerable users, particularly minors.
- TikTok's direct messaging and live streaming features present potential risks in this regard.
- Cases Highlighting the Danger of TikTok in South Africa:
 - In June 2021, a news report exposed a case where a predator utilized TikTok to groom and manipulate a minor in South Africa.
 - Posing as a teenager, the individual gradually established a relationship with the unsuspecting minor, leading to dangerous offline encounters.
 - This incident raised concerns about the platform's vulnerability to exploitation by online predators.

HEALTH AND WELL-BEING:

- Excessive use of TikTok, particularly among young users, can adversely affect mental health, body image, and self-esteem.
- Constant exposure to curated content and comparisons with influencers can contribute to feelings of inadequacy and psychological distress.

TIKTOK COMMUNITY GUIDELINES FOR SAFETY:

To ensure a safer environment for its users, TikTok has established community guidelines that address various risks and concerns associated with the platform. These guidelines are as follows:

- **Prohibition of Bullying and Harassment:**
 - TikTok strictly prohibits any form of bullying, harassment, or hate speech within the community.
 - Users are encouraged to treat others with respect and kindness.
- **Child Safety:**
 - TikTok is committed to ensuring a safe environment for minors and prohibits any content that endangers or exploits them.
 - Users are advised not to share or engage in inappropriate activities involving minors.
- **Personal Information Protection:**

- **Nudity and Sexual Content:**
 - TikTok maintains strict guidelines against explicit sexual content, nudity, or any form of adult content.
 - Users are expected to adhere to these guidelines and avoid sharing inappropriate material.
- **Copyright Infringement:**
 - TikTok enforces copyright rules and urges users not to post content that infringes on intellectual property rights.
 - Users should respect copyrights and avoid using copyrighted material without proper authorisation.
- **Authenticity and Misinformation:**
 - TikTok encourages users to be authentic and responsible in their content creation.
