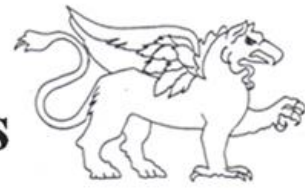

**PROJECT:**  
**THEFT AT MODIMOLLE**  
**GUEST HOUSES**

*The guest house guests in Modimolle were rudely awakened on Sunday morning to discover that their luxury watches had been snatched from their wrists while they slept. To make matters worse, their expensive and branded electronic devices were also stolen from their rooms.*







## THE CASE:

- Early on Sunday morning between 02:00 - 05:00, guests were robbed of expensive personal belongings valued at approximately a million rand.
- There were no signs of forceful break-ins and it is believed that the windows and the sliding doors were left open on purpose by people who had access to the rooms.

- Some of the guests stated that they had closed the windows and doors themselves before going to bed, but when they awoke the next morning, everything had been opened as it had been the previous evening before they closed it.
  - 3 Sets of footprints were found on the scene, one of these sets has been positively linked to that of another robbery earlier in the week at another guest house in the area.

## **THE MODUS OPERANDI OF THE RECENT BURGLARIES IN THE BELA-BELA AND MODIMOLLE AREAS:**

- In the period from January 2023 to July 2023, it is known that approximately 10 incidents occurred at various guest houses in the areas.
- The recent break-ins in these areas have been attributed to a group of three individuals who only strike on Friday and Saturday evenings or early Sunday mornings.
- These suspects are known to focus their attention on holiday times, school holidays, and the end of the month.
- It has been observed that holiday-goers bring valuable technology such as cell phones, cameras, and laptops to the lodges they stay in, and unfortunately, many of these lodges are not entirely secure, making them easy targets.
- The suspects closely watch the guests and steal from them when they sleep or attend functions.
- One of the suspects enters the chalets while the others carry the stolen goods to a nearby location where they are picked up by a vehicle and taken to Soshanguve or Atteridgeville to sell the stolen items.
- These suspects prefer expensive items like mobile phones, laptops, watches, and drones.
- They also steal cash.
- They walk on foot to avoid being noticed in the dark.
- Based on fingerprints and footprints found at the scene, the suspects are believed to be from Zimbabwe.
- Additionally, one of the suspects is described as being taller than the others.

## **WHAT DOES THE LAW SAY ABOUT BUYING STOLEN GOODS:**

- Section 36 states that any person who is found in possession of any goods to which there is reasonable suspicion that they have been stolen and is unable to give a satisfactory account of such possession shall be guilty of an offence and liable on conviction to the penalties which may be imposed on a conviction of theft.
