In April 2022, Johndrè van der Merwe was arrested with the help of the public, SAPS officials and representatives of the Community Policing Forum of George.

Although released on bail, he failed to appear for his scheduled court hearings.

Despite Mr Van Der Merwe's promises to cooperate during his phone conversation with specialist investigator Mr Jan Roos, SSS has yet to see any results.

Therefore, it is imperative that SSS continues our active search and apprehension efforts for Johndrè van der Merwe.
