IMPORTANT INTENSIFICATION
AND EXPANSION OF THIS CRIME
(PART 1)

During our extensive investigations in the past few years with regard to the extreme escalation of extortion and sextortion by SAPS impersonators and corrupt SAPS officials, we can confirm as a fact that these types of incidents are manipulated by syndicates in the South African Prison System.

The latest shocking information we have identified - concerning these extortionists/sextortionists, is that they are released at night and work from outside the prisons at night. The corruption of our prison system has escalated to such a level that these cybercrime criminals can bribe and influence their way out of prison at night and back into prison during the day! MODUS OPERANDI:

- We advise that you immediately stop any form of communication or interaction with these "officers".
- Their aim is always to extort money from you.
- They will claim that they can make this case or docket against you disappear and will assist you through the complicated process of dealing with the so-called victims, investigators, prosecutors, etc.
- The unfortunate and very real reality is that such documents and cases can indeed be fabricated, as has been done before.
- It is a serious concern to us as it is elementary to fabricate a complete police docket with false statements and information.
- Your personal information is readily available to these perpetrators.
- They will investigate your social media activities, use stolen identities of actual police officials and other cases.
- They will fabricate a whole new case around you.
- Information, documents and photos are manipulated to such an extent that, in effect, it eventually seems like a real and actual docket against you.
- When you are confronted by something like this, contact SSS immediately.
- Our specialist cybercrime unit is skilled in dealing with such cases specifically, and SSS works closely with the relevant authorities.

- The moment you open any site of a sexual nature whatsoever, you are immediately targeted, your information is gathered, combined and forwarded to the extortionists, who will manipulate, photoshop and change the facts to suit their crimes of threats, harassment, manipulation and extortion.
