# ALIASES: COLONEL BEN DU TOIT, COLONEL VAN DEN BERG AND ERIC LELAKE OF THE HAWKS



Our client was extorted in 2021 after getting involved on a website advertising a search for people who were prepared to make pornographic movies.

The extortion stopped after our client had made payments in excess of **R200,000.00**– but only for a short while.

Our client was contacted again in July 2023 by SAPS impersonators and he again had to make a series of payments totalling **R230,000.00** to the SAPS Impersonators.

On the 11<sup>th</sup> of August 2023, he contacted Mr Bolhuis for help.

### **MODUS OPERANDI:**

- "Colonel Ben du Toit" targets people who send naked pictures to ladies as well as people who visit massage parlours and sex workers.
- He phones the victim and informs them that he is investigating a case of fraud and rape and that a warrant of arrest has been issued.
- "Colonel du Toit" expects money to let this case "go away".
- He tells the client that he needs the money to pay off the sex worker and the prosecutor.
- Once some money has been paid, "Colonel du Toit" does not stop and demands more money for judges etc.
- Then "Colonel van den Berg" starts phoning the victim, stating that "Eric Lelake" from the Hawks is now involved because a SAPS member had been bribed and that the victim must pay even more money.
- This money must go to the Hawks, the doctor who examined the lady, administrative people to remove the case from the SAPS systems etc.
- He also "warns" the victim not to speak to any other policemen.


