

# PROJECT: MISSING PERSON'S CASE ESCALATED TO THEFT, KIDNAPPING AND MURDER MR DESMOND SHARE

The initial missing person's case has been escalated to a theft and kidnapping investigation and, with immediate effect, a murder case.

# SSS received the following public statement early today.

According to a public statement issued on the "Help Find Des" Facebook group by Mr Tertius Erasmus on the 8<sup>th</sup> of August 2023 that read:

"STATEMENT 08 August 2023"

"We extend our heartfelt gratitude to everyone who has contributed to the efforts in locating Desmond Share.

With heavy hearts, we must convey the devastating news that Desmond has been found, and he has tragically lost his life as a result of a violent incident.

In this somber time, we wish to express our appreciation to the law enforcement authorities for their exemplary and diligent work during this investigation.

The police have successfully apprehended a primary suspect, who is scheduled to be charged tomorrow, while three additional suspects remain at large.

Further information regarding the case will be disseminated by the police at the appropriate junctures.

Additionally, the family intends to issue their own statements in due course, and at this stage, we wish to ask for privacy for the family and close friends during this grieving time.

The reason for the delay in certain communications was to ensure the successful apprehension of the suspects. We are in the process of coordinating with the police to determine the extent of information that can be shared with the public to aid in the search for outstanding suspects.

We humbly request the public's cooperation in this endeavour. It's worth noting that the vehicle originally associated with this incident has undergone changes and is no longer visibly marked. We kindly urge the public to remain vigilant and report any sightings of a vehicle matching its description if advertised for sale or otherwise.

Once again, we express our sincere gratitude for the support shown during this trying time.

We urge the public to respect the family's privacy and not get involved in sharing false or sensationalised information.

There is still an active ongoing investigation by the authorities, and we ask anybody with factual information to come forward and assist in the investigation.

We applaud the authorities involved for their hard work and persistence in pursuing this case. The swift apprehension of a primary suspect is a testament to the professionalism and determination of those involved in this investigation. As we move forward, our faith in the justice system remains unwavering, as we trust that the appropriate legal measures will be taken to ensure that those responsible for this tragedy are held accountable for their actions. It is important to note that while one suspect has been apprehended, more suspects remain at large, underscoring the necessity of continued diligence in this case.

Should you have factual information regarding this investigation regarding Mr Share, SSS implores you to contact either the relevant SAPS officers or our task team.

- Additionally, we urge the public's assistance in identifying any information that may aid in the apprehension of the outstanding suspects.
- The community's vigilance and commitment to sharing accurate information can play a pivotal role in expediting this process.
- Please remain vigilant and report any sightings of a vehicle matching the description provided, especially if it is being advertised for sale or has undergone changes in appearance.
