

PROJECT: POLICE STATION REFERRALS TO OTHER STATIONS IMPORTANT NOTICE TO THE PUBLIC!

SSS has received numerous complaints regarding members of the public who are referred from one police station to another. The excuse is usually that a case must be reported in the area where the incident/crime occurred.

As previously stated by SSS, this is **NOT** the case.

NO SAPS officer is allowed to **DENY** you or a member of the public, service or to open a new case.

MORE REASONS FOR REFUSALS TO OPEN CRIMINAL DOCKETS:

- If the complainant cannot identify the suspect by name.
- The complainant did not bring the suspect to the police station.
- The crime did not occur within the station's boundaries.
- The member attending to the complainant does not think it is serious or severe enough.
- Complainants are told to resolve the dispute with the suspect.

PLEASE REFER TO THIS INTERNAL COMMUNICATION ALREADY ISSUED IN 2011 BY THE SAPS:

REFUSAL BY SAPS MEMBERS TO ASSIST COMPLAINANTS TO OPEN CRIMINAL DOCKETS IN TERMS OF NATIONAL INSTRUCTION 3 OF 2011

- 4.1 Complainants or reporters of crime, whether the crime was committed in his/her station area or in the station area of another police station, are treated courteously and that a comprehensive affidavit is taken from the complainant or report of crime;
- 4.2 Complainants or reporters of crime are not referred to another station to lodge complaints of crime;
- 4.3 All complaints or reports made by the public receive immediate attention.
- Cluster Commanders and Station Commanders must ensure that all members who do not comply with National Instruction 3 of 2011 are subjected to disciplinary steps.

Do not feel intimidated; instead, ask for the station commander if your request to open a case is refused.
