IMPORTANT NOTICE
TO THE PUBLIC!

SSS has received numerous complaints regarding members of the public who are referred from one police station to another.

SSS wants to state unequivocally that:

NO SAPS officer is allowed to **DENY you or a member of the public, service or to open a new case.**

NO POLICE OFFICIAL/OFFICER HAS THE POWER TO REFUSE ANY COMPLAINT OF A SUSPECTED CRIMINAL MATTER FROM A COMPLAINANT.

**THE FUNCTIONS/POWER OF A POLICE OFFICER IS CLEARLY STIPULATED IN THE CONSTITUTION OF THE RSA CHAPTER 11 (205) (3):-
"THE PURPOSE OF THE POLICE SERVICE IS TO PREVENT AND FIGHT CRIME. TO INVESTIGATE CRIME, TO OVERSEE AND MAINTAIN PUBLIC ORDER, TO PROTECT AND SECURE THE SAFETY OF MEMBERS OF THE PUBLIC OF THE RSA,
TO MAINTAIN AND APPLY LAW AND ORDER."**

- This chapter clearly refers to the competence and responsibility of a police officer.
- A police officer has no power to decide over the merits of a case or a complaint by a member of the public.
- The above chapter undoubtedly only gives the member the power to investigate the case and objectively gather all evidence in terms of the Criminal Procedure Act 51/1977.
- When the investigation is completed, the collected evidence/case docket must be forwarded to a Public Prosecutor to decide the merit of the case.
- From the moment that a criminal case docket is opened/registered, this case docket is the property of the office of the National Directorate of Prosecution and only this office has any power to decide regarding its merits.
- Should the Prosecutor decide to prosecute, the presiding Official/Magistrate is the only person who will decide if the accused is guilty or not.

COMMENT:

IT IS CLEAR FROM THE ABOVE CHAPTER OF THE CONSTITUTION THAT A POLICE OFFICER CANNOT BE THE INVESTIGATOR, PROSECUTOR AND THE JUDGE.

RECOMMENDATION:

- Numerous examples of police officers that decline to take statements or open case dockets from members of the public are known.
- Members of the public are encouraged to open criminal complaints of defeating the ends of justice against these police officials.
- The public must also make use of Police Standing Order 101 to open Departmental complaints against such police officials.

- Standing Order (SO) 101 regulates the activities, processes, practices and timeframes relating to the management of service delivery complaints lodged against the SAPS.

Do not feel intimidated; instead, ask for the station commander if your request to open a case is refused.

Cluster commanders and station commanders must ensure that all members who do not comply with National Instruction 3 of 2011 are subjected to disciplinary steps.
