

# PROJECT: BUSINESS ROBBERY SABLE ENERGY

#### THE ROBBERY:

- On Saturday, 29 July 2023, at approximately 11:00, our client worked with her admin personnel on the first floor.
- Two unknown African males came up the stairs.
- Both men had pistols in their hands.
- One firearm was a 9mm Parabellum handgun.
- One firearm was a 9mm short possibly a Norinco.
- Not one of the firearms was "cocked."
- The client initially thought they were lost and wanted directions.
- One of the men lifted his shirt and showed his firearm tucked in front of his pants.
- This suspect was wearing a dark blue long-sleeved shirt.
- The other suspect entered the other office and held those employees captive.
- He wore a red jacket.

- The client did not stand back for the suspect, confronted him, and attempted to defend herself.
- The two upstairs called two other suspects to come and assist them.
- The client and employees upstairs were forced into the admin office and were held hostage by the two males until the whole ordeal was over.
- Then the suspects left.
- The client was constantly beaten by 3 of the suspects.
- The suspect in the dark blue long-sleeved shirt vehemently continued his attack without any respite.
- This specific suspect had a large scar on the left side of his face.
- The client's vehicle keys and phone were taken from her.
- While the client and her employees were held hostage, she could observe how more suspects entered her warehouse and ransacked her merchandise.
- A white Hyundai H100 reversed into the warehouse, and numerous suspects (between 10 to 15 suspects) started to load her merchandise into this vehicle.
- The suspects attempted to tie the client up, but she freed herself each time.
- She was then assaulted again, especially in her face.
- They told her: "We're not here for you; we are here for our stuff."
- While the client witnessed the ransacking of her warehouse, two of her employees arrived at the office with one of her other vehicles.
- Firearms were pointed at them and they were held hostage.
- The suspects forced her employees to assist with loading her solar equipment into their vehicle.
- There was an African woman with the suspects.
- She knew exactly what to take and what to leave.
- She ordered the suspects to the merchandise which they had to take.
- She was very knowledgeable about the equipment in the warehouse.
- Before the robbers entered the Sable Energy building, a white male and white female entered and requested a pricelist.
- As the receptionist assisted them, the suspects entered the premises.
- These two white people are also suspects as they were part of the robbery:
  - They entered the premises and left the door open for the rest of the suspects to enter.
- They were untouched by the suspects, and they left the premises casually.
- On Wednesday, 26 July 2023, at about 13:00, an African male and female entered the Sable Energy offices and requested the sales lady to walk them through the showroom as they wanted to invest in solar energy.
- This lady, who was at Sable Energy on that Wednesday, was the same female that the client identified on the day of the robbery.
- The suspects stole the following:

- 5x laptops
- 9x cell phones
- Solar merchandise to the value of about R2,000,000.00.

The team at Sable Energy is making all efforts to rectify their current circumstances. They have successfully restored their communication channels after experiencing the theft of their cell phones and laptops.
