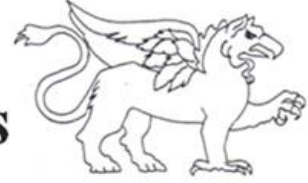

**1 SUSPECT HAS BEEN DETAINED AND 2 SUSPECTS ARE
WANTED FOR MURDER.**

ARREST WARRANTS HAVE BEEN ISSUED.

Specialised Security Services urges the public not to confront or attempt to detain the suspects yourself as they may be armed and dangerous.

If you see the suspects or if you have any information about the whereabouts of the suspects, please contact the responsible authorities.

AS PER THE OFFICIAL SAPS PRESS RELEASE DATED 15 AUGUST 2023:

"Shadreck Mhetu (30), charged in connection with the death of Desmond Share (53) made his court appearance on 15 August 2023.

Meanwhile, Mossel Bay Magistrates' court issued warrants of arrest for two more suspects. Investigation into the murder case positively linked Shown Gondo (31) and Akim Gondo (25) to the disappearance of the deceased. Photographs of the men are attached.

ANOTHER STATEMENT PUBLISHED ON THE "JUSTICE FIND DES" FACEBOOK PAGE READS:

"Warrants of arrest have been issued:

Desmond Share was reported missing on Tuesday, August 1st, after he failed to return home from a trip to Herbertsdale to provide a quote. His body was later found with multiple injuries near Albertinia on the road from Herbertsdale.

Shortly after his kidnapping, his bakkie was seen at a petrol station in Buffelsjag, and money was withdrawn from his account on two occasions. Meanwhile, 30-year-old Shadreck Mhetu, the first person arrested for the murder, appeared in court for the second time today and will remain in custody.

Mhetu was charged with murder, hijacking, and kidnapping after being arrested in Da Noon in Cape Town. His case was postponed to August 22nd in the Mossel Bay Magistrates Court.

The investigation into Share's kidnapping and murder led to the discovery of his vehicle and the issuance of a warrant of arrest for two more suspects. Share's Ford Ranger bakkie, which was branded with his business name "Gutter Guru," was found in Ficksburg in the Free State near the Lesotho border last week.

Two suspects were arrested in connection with the stolen vehicle and were remanded in custody until Thursday, but there is no evidence linking them to Share's murder.

Warrants of arrest have been issued for 25-year-old Akim Gondo and 31-year-old Shown Gondo, who are connected to the murder. Anyone with information on their whereabouts or any other information can contact the Da Gamaskop police station or Warrant Officer Arleen Stokes at 072 461 9329."
