SSS has been mandated to do an in-depth investigation into the robbery at the premises of Sable Energy. We would like to update the public on the events since the investigation started.

THE INVESTIGATION AND RESULTS:

- SSS and the SAPS investigated and acted on information gathered from the victims after the robbery.
- CCTV footage of suspects was shared on social media, and this led to the identification of a white male and female by the local community.
- With the SAPS assistance, SSS pursued multiple leads, which resulted in the two suspects surrendering themselves.
- Neville Coetzee was arrested on 2 August 2023 but later released on bail.
- Dominique Ras was questioned and released on the condition of providing cooperation and information if needed.
- All Sable Energy employees and Bomb Squad security guards underwent polygraph tests.

- Lindani Malinga, the security guard, was detained for further investigation owing to deception detected on the polygraph test and lacking because he lacked the necessary registration documents.
 - Despite gathering more evidence, SSS was let down by SAPS and the justice system, leading to the suspect's release.
 - As a foreign national, it may be difficult to re-arrest him.
