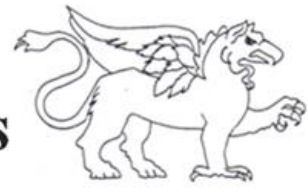
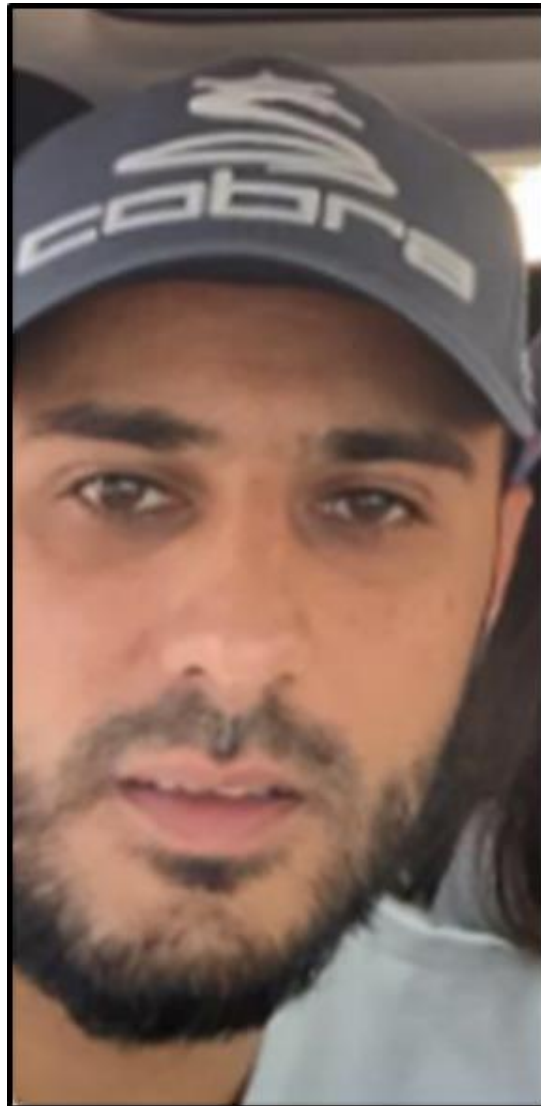

- Mr Naeem Mahomed has been confirmed to be a director of "Haksone Investments CC".
- The creditors' preferred liquidator, Mr A.W Van Rooyen has been appointed and, upon receipt of the certificate of appointment, will proceed with the following:
 - Instructing the sheriff to uplift all documents in purport of Section 19 of the Insolvency Act;
 - Convening an enquiry in terms of Section 64 et al . . . of the Closed Corporations Act;
 - Proceeding to recover funds in the purport of Section 71 of the Closed Corporations Act.
