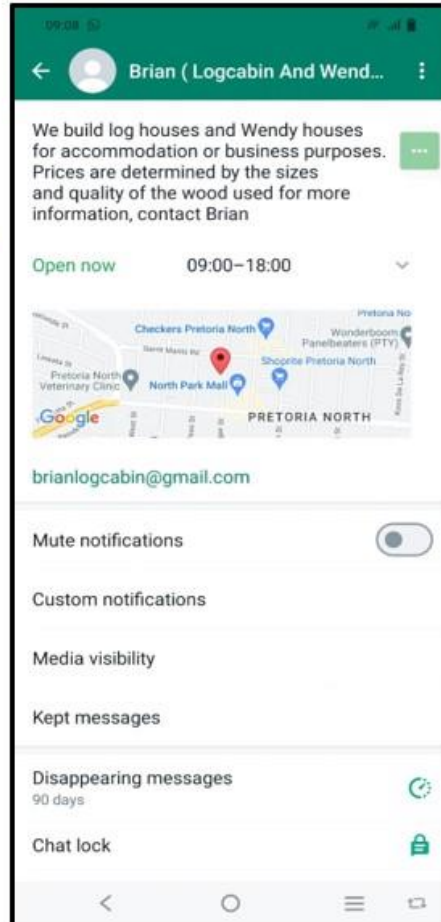
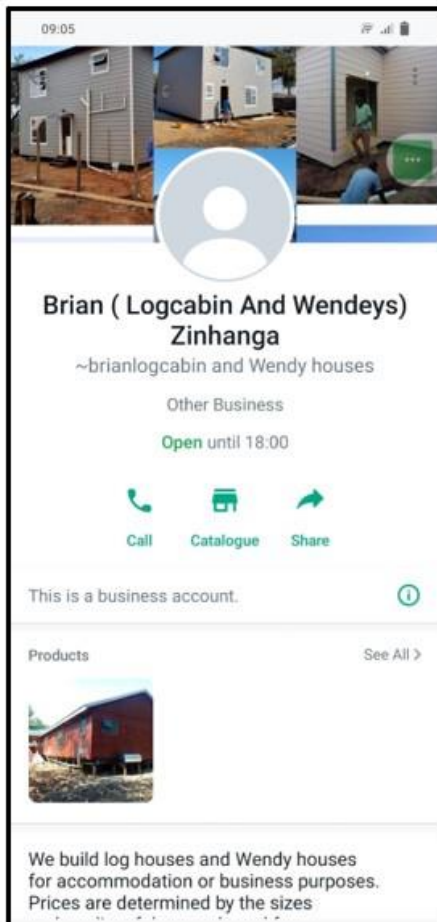
*Log Homes (Pty) Ltd, represented by Blessing Zinhanga, also known as Brian, is one such company.*

- Our client contacted Brian to build a log home in the Vaal Marina.
- Our client paid R51,288.57 directly into the bank account supplied by Brian:
  - Bank – FNB Gold Business Account
  - Account number – 630465965582
- According to their agreement, the building of the log home would have started on the 14<sup>th</sup> of July 2023.
- To date, Brian has disappeared with the client's payment and the building materials he supposedly bought with the payment.
- He is also not answering any calls.

## **IMPORTANT:**

When navigating Facebook Marketplace, it's crucial to be vigilant for potential red flags that could signal a risky transaction:

- Firstly, exercise caution if the price seems too good to be true, as this might indicate a scam or counterfeit item.
  - Secondly, be wary of sellers who rush the transaction, refuse to provide additional information, or avoid meeting in a public and well-lit location for the exchange.
  - Thirdly, if a seller insists on using unconventional payment methods or requests sensitive personal information, it's wise to reconsider the deal.
  - Moreover, carefully scrutinise images and descriptions for inconsistencies or stock photos, which could suggest dishonesty.
  - Lastly, trust your instincts – if something feels off or suspicious, it's best to walk away from the deal.
  - Stay informed, ask questions, and prioritise your safety when engaging in transactions on Facebook Marketplace or any online platform.
