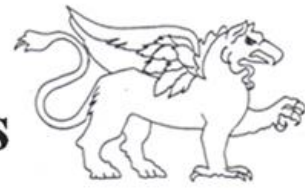

is officially missing for 12 years!*

- Ralph Haynes disappeared on 21 January 2011.
 - Despite ongoing investigations, no new information has been released since then.
 - He was last seen leaving Kitty Hawk Aerodrome in a helicopter - the SAPS has been investigating his disappearance from Middelburg in Mpumalanga under case number SAPS Middelburg CAS 10/01/2011 ever since.
 - The National spokesperson of the SAPS, Colonel McIntosh Polela, made a statement to the media shortly after his disappearance, stating that Ralph Haynes was not dead but hiding in a neighbouring country.
 - This claim remains unverified, and Ralph Haynes is still missing.
 - No arrest, as suggested at that time, was ever made.
 - Before his disappearance, Ralph Haynes was arrested in 2010 on a fraud case and was released on bail.
 - He later failed to attend court on this matter, and a warrant for his arrest was issued under case number SAPS Krugersdorp CAS 215/10/2010.
 - It is reported that Ralph Haynes had seen Mr Mike Bolhuis on several occasions in 2010 and 2011 before his disappearance.
 - He informed Mr Bolhuis that he knew the police would soon be knocking on his door and that Asset Forfeiture would be involved, resulting in him losing everything.
 - Haynes was aware of the investigations against him.
 - Mr Bolhuis kept the police informed on these meetings.

- Ralph Haynes disappeared because of relentless pressure from the SAPS.
 - The police received information and help regarding the investigation of Ralph Haynes from many different people.
 - Ralph's wife at the time, Jackie Haynes, appointed Mr Mike Bolhuis on the day of his disappearance to assist in tracing him.
 - In hindsight, this appointment and request were premature.
 - An affidavit confirming this appointment was obtained from her on 25 March 2011.
 - In the meantime, Jackie has made many negative comments regarding Mr Bolhuis, the SAPS in general and specifically about a Colonel who had lost his job in the police.
 - Her account of this Colonel was that he had always given her an unfair and tough time and that she was pleased that he was sacked by the SAPS.
 - According to her, it proved that she was right about him.

- She turned to a journalist who wrote a book on her life and her experiences with her husband, an infamous man with a diverse history, to say the very least.
 - She was interviewed by Huisgenoot magazine in 2018 with the new love of her life, Dawie Lotter, a member of the Mac's motorcycle group and the former right-hand man and trusted friend of the missing Ralph Haynes.
 - She remarked in the article that Ralph stole for a living and never had a permanent job or monthly salary.
 - She further remarked that he taught her: "See nothing, hear nothing, know nothingeven if your neighbour is shot next to you, look straight ahead. You saw nothing".
 - She is active on social media, still criticising certain people and wondering what happened to Ralph Haynes and where he is.
