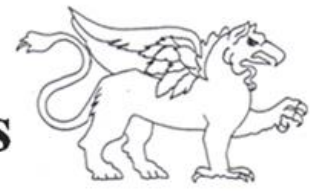




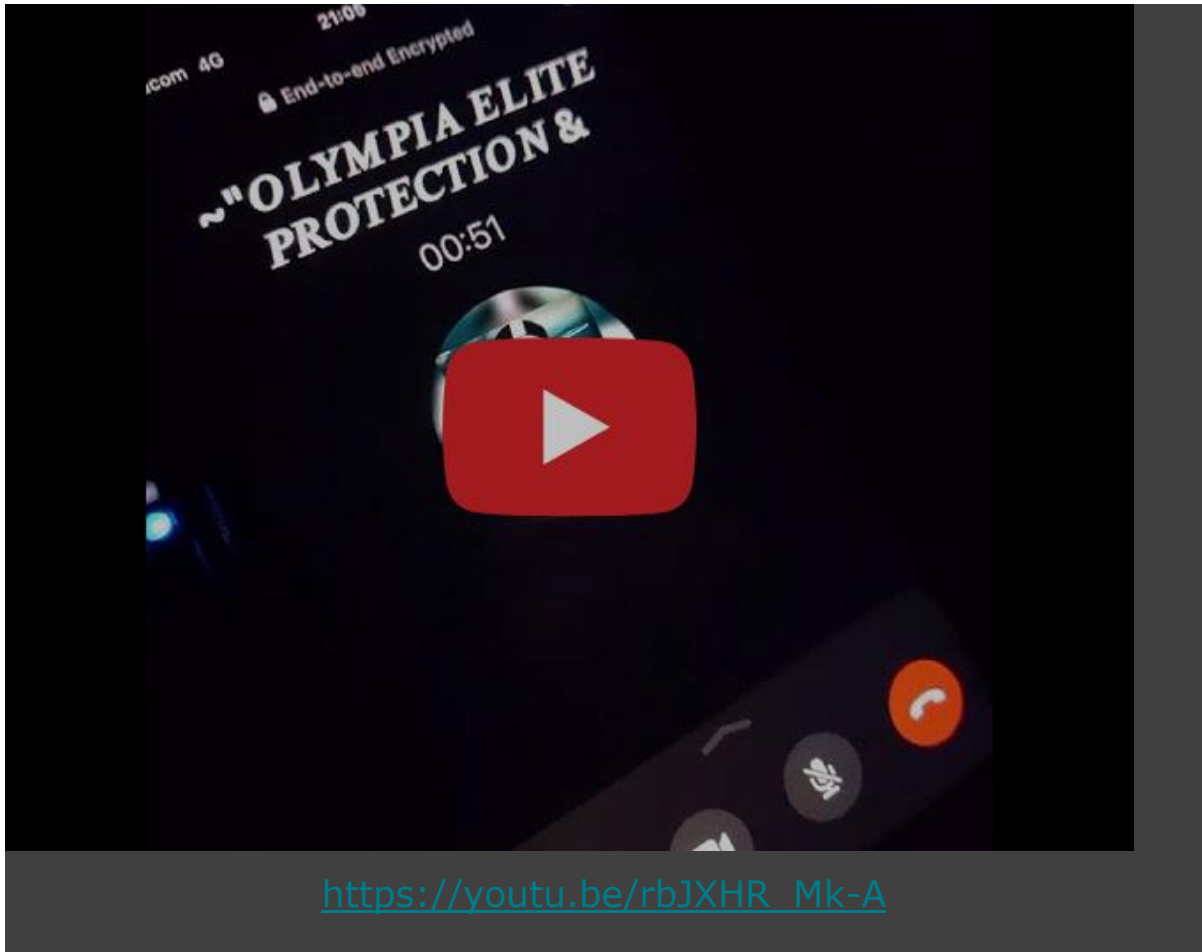

- This company is *not* PSIRA registered.
- The Mandate of PSIRA derives from the Private Security Industry Regulation Act 56 of 2001.
- The primary objective of the Authority is to regulate the private security industry and to exercise effective control over the practice of a security service provider in the public and national interest and in the interest of the private security industry itself.
- According to the PSIRA Act, Wesley Roux and his company are not allowed to claim that they can provide the following services as advertised:
 - Close protection of VIP's.
 - Local and Overseas Close Protection.
 - Bulletproof Vehicles.
 - Safehouses.
 - Security Patrols.
 - Security Guards.
 - Armed Response.
 - Armed Escorts.

- Wesley Roux does not have any competency certificates. He may not carry or use any weapons - this is *not* what he portrays in the numerous pictures taken of him.



CURRENT SAPS CASE OPENED AGAINST WESLEY ROUX:

- A criminal case in the Johannesburg area:
 - Intimidation as well as Crimen Injuria.
- Another client contacted SSS and gave a statement that Wesley Roux defrauded her of R21,000.00.
 - Failure to do agreed-upon debt collection and failure to protect the client.
- SSS is aware of more cases against Wesley Roux and many ongoing investigations.

MODUS OPERANDI:

- Although Wesley Roux is not qualified or accredited at all or behaves as if he is, therefore, he misrepresents himself, his skills and his services.
- He agrees to deliver certain services for financial gain.
- Wesley Roux usually does not deliver a successful resolution of the instruction or the services he promised.
- He then refuses to refund any advance payments or demands additional payments by way of manipulation/extortion/threats.

As soon as he is exposed as the racketeer that he is, he threatens his paying clients/victims with:

- **kidnapping of their children,**
- **rape of women and children,**
- **bodily harm and even death.**

We have requested that the SAPS centralise all cases brought against Mr Wesley Roux and his crew.
This request has been granted.

Mr Wesley Roux has evaded jail on several previous occasions because his victims are too scared to open cases against him. We, therefore, urge the public to send all information of cases already opened against him to us for our immediate attention.

If you have not opened a case yet, **please do so** as soon as possible. Send the case numbers, details of the investigating officers and all relevant information and proof to us.

We will send it to a trustworthy police officer in the centralised task force appointed.

It is important to keep in mind that you might be threatened or intimidated to NOT open cases and NOT to send the cases to our organisation.

Remember that we have already posted numerous project documents as warnings to the public against Wesley Roux and his associates!

We have a proven track record of our pursuit to apprehend him.

Do not be intimidated

- rather, contact us to stop these criminals from future verbal and physical abuse/exploitation and extortion.

We need to combine our efforts for a successful arrest and prosecution.
