

PROJECT: ARMED ROBBERY AND STOLEN LUXURY ITEMS

Specialised Security Services has been mandated to help our client after his private residence was brazenly robbed yesterday morning, Tuesday, 17 October 2023, in broad daylight.

THE ROBBERY:

- According to what our SSS specialist investigator, Mr Jan Roos could ascertain, 4 African males were driving in a black BMW in Ferox Street, Amandasig, Pretoria North.
- One of the individuals jumped the wall of our client's premises at approximately 09:30 on Tuesday morning, 17 October 2023.
- This robber then opened the gate with a remote from inside the premises.
- All four looters had masks drawn over their faces and were armed.
- They held the 3 people working for our client at gunpoint while they ransacked the house.
- They were able to allocate the safe and took the following items:
 - A Rolex watch worth R200,000.00.
 - 2 Gold Lanco watches.
 - 2 Hunting rifles.
 - A Samsung TV worth R10,000.00.
 - 1 ACER laptop which cannot close.

THE ROLEX WATCH:

- Rolex Yacht-master 40, Blue Dail, Stainless steel.
 "Janse van Rensburg" is engraved on the side and "Tour de France 2016", on the back.



GOLD LANCO WATCHES:

- These 2 watches were bought over 30 years ago for our client by his wife.
- It has sentimental value for them and is quite distinguishable.

- Neighbours contacted our clients and told them of the robbery in progress next door.
- Our clients rushed home and were met by the SAPS but the robbers had fled by this time.
- The SAPS officers combed the house for the necessary forensic evidence.
