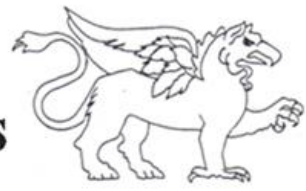




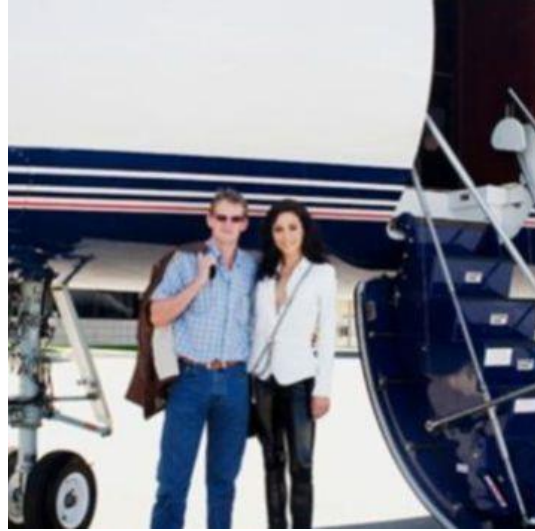
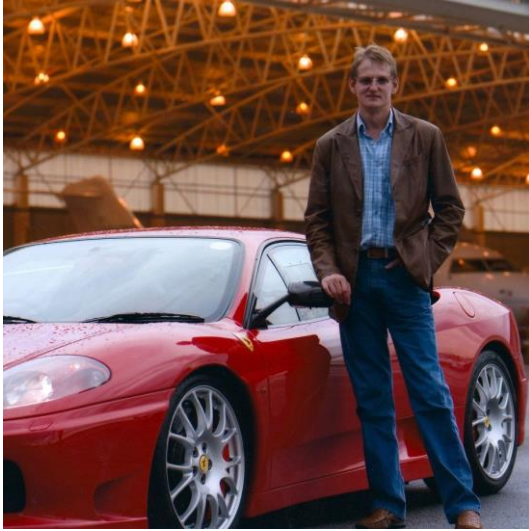

 - His partner, Tim Pretorius, was the Director of Gate Investments (Pty) Ltd and has been convicted of fraud in the Commercial Crimes Court in Pretoria.
 - However, he has become the scapegoat for Nel's dishonest dealings.
 - Nel changed his name and had his criminal record stolen by a corrupt police officer.
 - He then claimed that all crimes logged on the South African Criminal Record system did not belong to him and went to court with such an application.
 - The High Court in Pretoria dismissed his application and ruled that his criminal record remains on the South African Criminal Record system.
