- This is a grave injustice to individuals who sought to improve their circumstances and were instead left to bear the burden of a criminal enterprise's deceit.
- This is not an isolated case. Currently, there are *several* other Ponzi schemes operating concurrently in South Africa.
- To our dismay, these schemes often target unemployed individuals who are searching for online income opportunities.
- Some people have been employed as online administrators tasked with recruiting, promoting, and distributing the Ant Ranch name.
- They, too, have become victims in this elaborate web of deceit.




