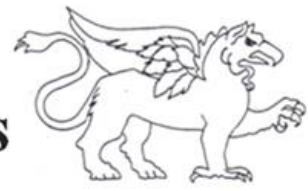

*The brutal murder of Mrs Ria Jansen Van Vuuren shocked the Orkney community, split a family and exploded into a social media war.*

*18 June 2023 will be remembered for the tragic death of Mrs Jansen Van Vuuren. It will also be remembered as a showcase of the insensitive temperament of so many members of the public in their attacks on each other on social media.*

*Specialised Security Services has been mandated to help resolve this sinister case.*

## **THE INCIDENT:**

- On 18 June 2023, Johannes Jansen van Vuuren shot Ria Jansen van Vuuren with a shotgun in the face at their residence in Orkney.
- A case of murder was opened and investigated by the Orkney SAPS Detective Service.
- Johannes Jansen van Vuuren was arrested, and court procedures started.
- He was released on bail of R3000,00.
- He alleged that the shooting incident was an accident and that he had wanted to show Ria how the firearm works.
- The court case against him was postponed to 27 November 2023.
- Ria's family requested that Mike Bolhuis and his team assist with the investigation since they did not get adequate feedback and still had questions regarding the murder case.
- During the investigation, numerous family members, colleagues and residents from Orkney were interviewed.
- It was clear that Ria had been in an abusive relationship.
- She had been regularly assaulted physically and often abused verbally.
- She decided to leave Johannes at the end of June 2023.
- They had been divorced in 2008 for the same reasons: threats, assault, and verbal abuse.
- He had threatened her with the children.

- After the divorce, between 2008 and the date of Ria's demise, she had returned to Johannes since he had made numerous promises to change, saying he would not repeat his past abusive behaviour.
  - The relationship was on and off between 2008 and the day of Ria's death.

## **JOHANNES JANSEN VAN VUUREN**

- Johannes Jansen van Vuuren was released on bail for the murder of his wife and has since passed away.
- He died on 11 October 2023.
- The cause of his death has not been confirmed yet.

- The SSS Specialist Investigators contacted the SAPS officer initially assigned to the case.
  - The cooperation we received was limited and inadequate.
  - It was then decided by our specialist investigators to contact the SAPS Provincial Head of Detectives of the North West Province.
  - The North West SAPS Provincial Head of Detectives immediately arranged for assistance.
  - Our assigned specialist investigators forwarded many questions to the SAPS - and we are awaiting their response.

*The SSS specialist investigators appreciate the immediate intervention of the SAPS North West's Provincial Head of Detectives and his concerns regarding the tardiness of the initially assigned SAPS investigator.*

- Numerous slanderous allegations and comments were made on social media.
  - Unfounded verbal arguments about the incident have been made between family members, friends, and other parties.
  - All parties are requested to refrain from getting involved in these misleading arguments.
  - Rely on facts and information that can be proven - not on lies, allegations, and gossip.
  - The distribution and posting of false information and disinformation is a crime which can have dire consequences.
  - Such debates exacerbate the trauma of the family who must deal with the death of a loved one.
  - This behaviour can also have an extremely negative impact on an ongoing investigation.
