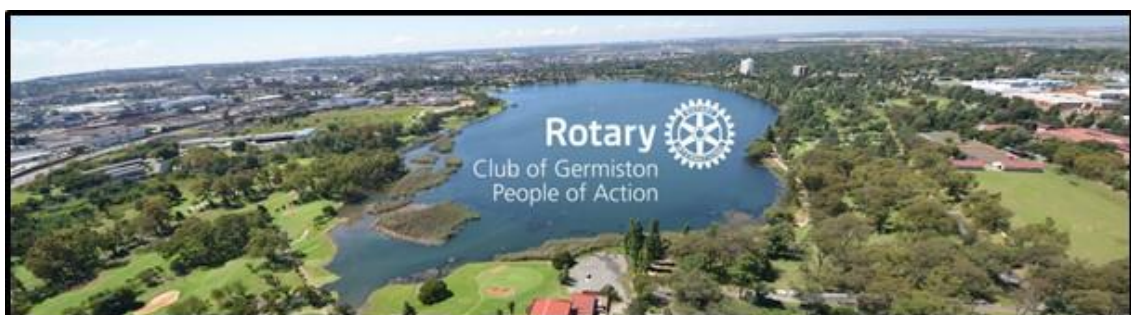


MR BOLHUIS VISITS THE GERMISTON ROTARY CLUB

TOPICS DISCUSSED AT THIS EVENT:

- The difference between hearsay, and factual information.
- What to do when someone is suspected of theft.
- SAPS:
 - The public's difficulty when laying charges at SAPS-stations and the reluctance of the SAPS and other government authorities to deal with or help the public.
 - The lack of visible policing, the depletion of their skilled officers from specialised units and the involvement of SAPS individuals in crime and corruption.
 - Misrepresentation, theft and fraud of SAPS officials.
- Private property and trespassing.
- Personal responsibility for owning a firearm:
 - Thorough risk analysis of the dangerous situation.
 - The private use of firearms in self-defence.
