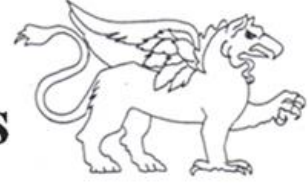

CHEVONNE RUSCH
(PART 3)
GUILTY VERDICT



Specialised Security Services was appointed to investigate the circumstances regarding the tragic death of Chevonne Rusch.

We are elated to inform the public that the people responsible for this heinous crime were found guilty today in the Johannesburg High Court.

*Her mother, Rochelle Botha and stepfather,
Stephan Van Niekerk,
will receive sentencing for their murderous
crime on 2 February 2024.*

THE GUILTY VERDICT:

- 2-Year-old Chevonne Rusch was admitted on 11 May 2022 to the Primrose Clinic in Germiston.
 - On arrival, this little girl was declared deceased.
 - Her mother and stepfather were found guilty today, the 17th of November 2023, of several charges, including but not limited to:
 - Murder.
 - Attempted murder.
 - Rape.
 - Human trafficking.
 - Child Abuse.
 - Child Neglect.

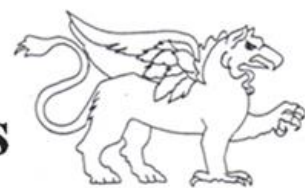
