

PROJECT: CRIME DURING THE FESTIVE SEASON (PART 3) SAFETY IN SHOPPING MALLS

Shopping malls play a central role in festive preparations, drawing in many visitors. It is critical to emphasise the need for a proactive approach to guarantee the well-being of shoppers, staff, and the community at large. SSS continues to forewarn the public and advocates personal safety measures in place.

GENERAL RULES:

Non-negotiable guidelines for personal safety in shopping malls:

- Avoid being alone in high target stores around opening and closing times.
 - These stores are banks, jewellery stores, and cell phone stores.
- Be observant at all times.
- Be aware of shoppers around you and anyone following you in the parking area.
 - One right turn is a coincidence.
 - Two right turns cause suspicion.
 - o Three right turns indicate that they are following you.
- Report any suspicious behaviour immediately to the shopping centre management, the information desk, or security staff.
- If robbers demand your vehicle or a personal item, hand it over immediately.
- Do not confront anyone yourself unless you are professionally trained to handle such situations.
- Do not wear expensive jewellery, shoes, or handbags when shopping.
- Use a sling bag across your body and always keep it zipped up.
 - Men should wear their wallets in an inside pocket and not in a trouser pocket.
- Never place your cell phone in your trouser pocket.
 - Do not place your cell phone, purse, or wallet on a counter.
 - Ensure your cell phone is fully charged.
 - Do not get distracted by messages or texting because a distracted target is a vulnerable target.
 - Do not use public WIFI in shopping malls because some hotspots do not encrypt wireless data, which may lead to identity theft.
- Presume that you are being watched.
 - Thieves do their homework and are acutely aware of every opportunity that presents itself.
- Various syndicates focus on high-end valuables such as Rolex watches, cell phones, cash withdrawals, etc.
- Do not carry too much cash with you at any time.
- Never withdraw copious amounts of cash at ATMs or inside the bank.
 - Thieves have informers standing around high-target stores or working in banks, relaying information.
- Human Trafficking syndicates target shopping malls during this time of the year:
 - o If possible, do not take your small children to malls.

- Do not leave your teenagers unsupervised at shopping malls for extended periods.
- Children with cell phones should be forewarned of the dangers at shopping malls and should keep their phone's "live locations" on.

SHOPPING MALL PARKING LOTS:

- Always park in a well-lit area, as close to the entrance as possible.
- When parking at a shopping mall, make sure to double-check that your car is locked to prevent remote control through carjamming devices.
- Show your children where the security guards are so they know where to get help if they get lost.
- Ensure your children know your cell phone number.
- Have a set meeting point in a public space if you get separated.
- When leaving a store, make sure to have your car keys in your hand before heading to your car.
- When you return to your car, be aware of your surroundings.
- Do not walk directly to your car when leaving the store.
- Instead, walk up to your car at a right angle to better view your surroundings.
- If you suspect you are being followed, do not drive directly home, go to the nearest police station instead.
- Do not place your shopping bags on the back seat of the car. Instead, place them in the trunk. By doing so, you can avoid inviting a smash-and-grab with visible bags on your back seat or on the empty passenger seat.

DRIVING HOME FROM THE SHOPPING MALL:

- It is important to be cautious when leaving a mall, as there have been reports of robberies occurring outside the parking area and during your drive home.
- Informers are known to provide information to robbers and hijackers about potential targets outside malls.
- Be aware of your surroundings and ensure that you are not being followed.
- Use your rear-view mirrors to keep an eye on anyone suspicious and, if necessary, drive directly to the nearest police station before stopping anywhere else.
