PROJECT: **BOUWER MURDERS**

*URGENT REQUEST FOR
INFORMATION
FROM THE PUBLIC!*

- On Monday 21 January 2024, Anton Bouwer allegedly went to his parent's home in Bredell, Kempton Park where he shot both his parents Bettie (73) and Barry Bouwer (78).
 - According to information, he then went to his residence in Fairleads, Benoni where he shot his adopted daughter Natasha Bouwer (22), the family's maid Elizabeth Mahlangu (55) and his wife Adelle (55).
 - His wife Adelle survived the incident, and her condition is stable.
 - She is currently recovering in the hospital.
 - A day after the incident, the family contacted Mr Mike Bolhuis of Specialised Security Services and our organisation was requested to investigate the incident.
 - The family believed that Anton Bouwer was not capable of the aforementioned acts.
 - Investigation revealed that Mr Bouwer had been arrested and was in hospital under police guard.
 - The family was notified accordingly.
 - They did not want to believe his guilt and requested Mr Bolhuis to stop the investigations.
 - Anton Bouwer has already appeared in court on 4 charges of murder, one of attempted murder as well as a charge of obstruction of justice.
 - The last court appearance was on Friday, 2 February 2024, at which bail application was postponed for 2 weeks.
 - The case has since been transferred to the Ekurhuleni District Detective Office.
 - SSS investigators are currently working closely with the SAPS and various leads and information are being followed up.
 - Mr Danie Day, a private detective who investigated the murder of the Bouwers' son Robbie in 2011, works with the SSS team.
 - Allegations in 2011 suggested that Anton Bouwer was also involved in his brother's death, but this could never be proven.

Any person with information regarding the incidents is requested to contact the investigation team.

All information will be treated as extremely private and confidential and will be shared with the investigating police officer after verification.
