


BACKGROUND:

- Wesley Roux, a violent and dangerous criminal, has been on the run for several offenses, including pointing an AK-47 assault rifle.
- His actions have posed a serious threat to public safety.

THE OPERATION AND THE ARREST:

- The SSS Specialist Task Team and Cyber Team together with Seargeant Motau from Garstfontein SAPS worked tirelessly to locate and apprehend Roux.

- Today, in a swift and coordinated operation, law enforcement officers cornered Wesley Roux.

 Despite his attempts to evade capture, he was successfully apprehended.



THE CHARGES:

- Roux faces charges related to pointing a firearm, assault, and intimidation.
- His reign of terror has come to an end.
- With Wesley Roux behind bars, the community can breathe a sigh of relief.

- The streets are safer, thanks to the efforts of the dedicated SAPS Officer.
- This successful operation serves as a reminder that justice prevails, and those who threaten our safety will be held accountable.
- Our latest project was sent out, and he was arrested within an hour.
- Our Cyber team, together with the SSS task team, Antoinette Coetser, and Chris Coetser, managed to locate him, after which he was apprehended at 15:45 on Monday 12 Feb 2024.
- The SSS cybercrime team picked up on his electronic footprint

 after which he was identified by a member of the SSS task
 team.
- The authorities were alerted to his whereabouts and arrangements were made for his immediate arrest.
- We also extend our gratitude to Sergeant Motau from Garstfontein SAPS.
- The SSS Specialist Task Team and Cyber Team together with Sergeant Motau from Garstfontein SAPS worked tirelessly to locate and apprehend Roux.
- Their dedication and strategic planning paid off.

We again appeal to members of the public, who have had problems with Wesley Roux to open police cases against him – so that a complete picture of his activities can be presented in court.

We are overjoyed that this dangerous man is in custody – and we trust that he will be charged and processed according to the law.

Well done to all parties involved in the arrest.
