#### **BOUWER**



- On Monday, 21 January 2024, Anton Bouwer allegedly went to his parent's home in Bredell, Kempton Park, where he shot both his parents, Bettie (73) and Barry Bouwer (78).
- According to information, he then went to his residence in Fairleads, Benoni, where he shot his adopted daughter Natasha

- Bouwer (22), the family's maid Elizabeth Mahlangu (55) and his wife Adelle (55).
- His wife, Adelle, survived the incident.

### BAPSFONTEIN FARM ATTACK JAYDEN LOUW




- On 7 October 2023, suspects entered the house of a family in Bapsfontein.
- The 14-year-old child went to the safe and fetched a firearm.
- He shot and injured one suspect.
- The suspect shot back and the boy was killed.
- The one vehicle used by the suspects was recovered, and arrests were made.
- The firearm of the owner was also recovered, and more arrests were made.
- Currently two cases are under investigation and suspects on trial.
- Welbekend CAS 24/10/2023 and Crystal Park CAS 83/10/2023.

#### **ASHEN NAIDOO**



- On 7 July 2023, the victim, Ashen Naidoo, was kidnapped/hijacked near his home in Midrand.
- His body was found strangled inside his vehicle on 9 July 2023 in Primrose.
- Information leads to him being extorted for money and held hostage in the Primrose/Bedfordview area.
- Primrose CAS 223/07/2023 murder is under investigation.

# BYENES, BLOEMFONTEIN BETSIE KRUGER, JANINE THERON AND CHRISTO THERON



- On 29 June 2023, Betsie Kruger, her daughter Janine Theron and son-in-law Christo Theron were found dead at their daycare centre in Wilgehof, Bloemfontein.
- Information indicates that the motive of the murder was theft of money.
- The victims were brutally tortured and it is suspected that some of the suspects were known to the victims.
- Parkweg CAS 1245/06/2023 murder is under investigation.

#### **JACKIE VAN ASWEGEN**



- It is alleged that Jackie van Aswegen was attacked at her residence in Brakpan on 21 September 2022.
- Her throat was cut with a knife, and she was taken to the hospital, where she succumbed to the injuries the following day.
- Her son and his accomplice were arrested and are currently in custody.
- The investigation is ongoing.
- It is believed by the family that a third party might be involved in the planning of the murder.
- Case number: SAPS Brakpan CAS 290/09/22.

#### PRISCILLA DU TOIT



- On 17 October 2019, Priscilla du Toit was murdered at her residence in Fourways, Randburg.
- Her almost unrecognisable body was discovered a few days after no one had heard from her.
- Video footage of the complex where she resided mysteriously also disappeared.
- Numerous mistakes were made by the SAPS attending the scene and the case of murder is currently being investigated by the SAPS National Detective Services.
- Douglasdale CAS 446/10/2019 refers.


