THE NEWEST AND LATEST CASES AGAINST WESLEY ROUX:

- SAPS GARSFONTEIN: CAS 348/01/2024
 - Pointing of Firearm.
 - After a disagreement, Wesley Roux pointed an AK-47 assault rifle at the people he was arguing with.
 - He threatened to kill the victims he was assaulting.
- SAPS GARSFONTEIN: CAS 347/01/2024
 - Assault.
 - After another incident, Wesley Roux seriously injured the victim, who was later hospitalised.
- After being arrested and imprisoned on 12 February 2024, Wesley Roux was released on bail on 14 February 2024.
- He was granted bail, because of the following:
 - He showed the SAPS that the weapons used for pointing at his victims were only plastic toy guns.
 - Take note that it is a crime to use toy guns to threaten anyone or to commit a crime.

 - He convinced the judge that the aggravated assault case should be changed to only assault.
 - Another assault case against him at the Brooklyn SAPS police station is being investigated.
 - The pending cases against Roux are ongoing and are being monitored.
 - SSS will keep the public informed of their progress.

On confrontation, Roux's aggressive demeanour disappears and he becomes completely vulnerable.

This was clear during his arrest when he frantically called his mother and cried emotionally, saying: "Mommy, Mommy, Mike Bolhuis se mense is weer op my." His mother is his "go-to guy" she always intercedes when he is in trouble with either the SAPS or when being investigated by SSS.

On the same day of the arrest, the SSS specialist investigator Mr Chris Coetser invited Wesley Roux to meet with him and Mr Mike Bolhuis after his release.

This invitation to Roux remains, and we would like to reiterate our concerns for him and his volatile actions.

Mr Bolhuis and SSS have an open-door policy and will offer assistance to those who need help or require it.

AN EMOTIONAL AND VOLATILE WESLEY ROUX WHEN ARRESTED:



Wesley Roux - Emotional and Volatile when Arrested

- Wesley Roux has committed an array of offences.
 - He commits serious violent and serious economic offences regularly.
 - His latest trick is to point firearms at his victims and threaten to kill them.
 - While the firearms *may* ridiculously be toys/plastic guns – the victim will not know the difference and will perceive the threat to be very real.
 - It is important to know that Wesley Roux is not certified or qualified to carry arms nor to offer safety and security services.
 - Although Wesley Roux had toy guns in this specific case, it still remains extremely dangerous to assume that any of his other firearms are harmless.
 - The fact remains that he may point a real gun at someone and cause serious harm when he discharges it.
 - It is a known fact that he has real weapons illegally in his possession.

- With his history of narcissistic behaviour and short-tempered, irrational and violent responses, he remains a dangerous and volatile threat to society.

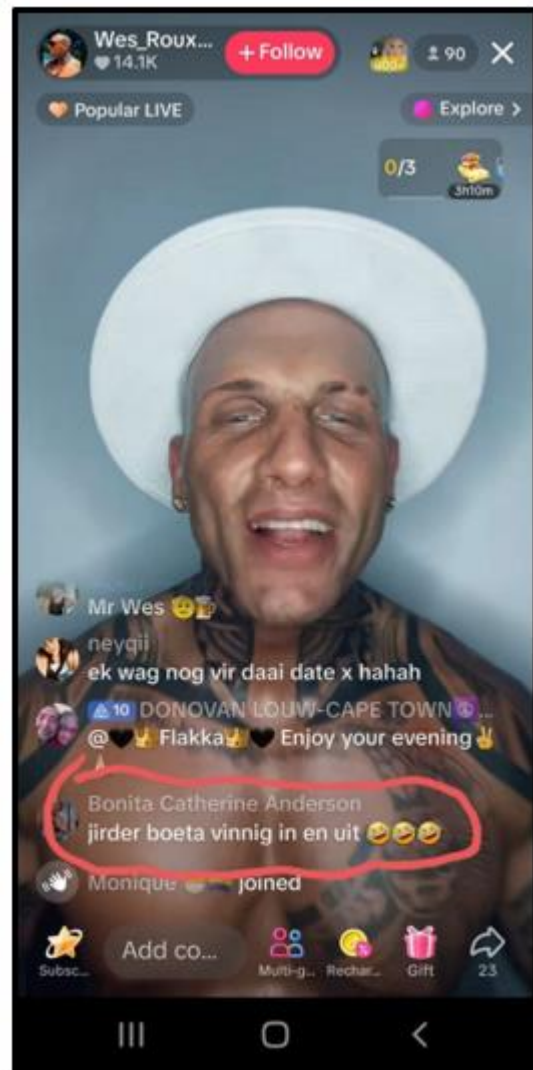
Whether serious and violent threats are made with plastic toys or fake guns, Wesley Roux's intent remains singular in threatening to kill civilians.

The level of intimidation remains extreme as his victims believe that they will die.

- The legal position of pointing a firearm at someone:
 - It is an absolute violation of the law to point a firearm at someone in South Africa, regardless of whether the gun is loaded or not.
 - Section 120(6) of the Firearms Control Act 60 of 2000 strictly prohibits the act of pointing any firearm, antique firearm, airgun, or *anything that may resemble one* at any person without good reason.
- South African laws clearly state that a licensed firearm can only be used for a lawful purpose and in a safe manner.
- If you own a gun for self-defence, it is crucial to remember that it can only be used to protect yourself against an unlawful attack.
- Any person who points a firearm at someone or discharges it in public can face severe criminal charges, and their license may be revoked.
- It is essential to understand that pointing a firearm at somebody without good reason is a grave offence, and it can lead to a 10-year prison sentence.
- We urge everyone to use their firearms legally and responsibly to ensure their own and others' safety.

- It is imperative that you take note of the following information: Roux is currently advertising his services as a specialised security officer on social media under the username @R314-99.
 - We remind you that, as previously mentioned in Project Wesley Roux Part 7, he is operating as a non-registered PSIRA company which means that he is misleading clients and misrepresenting himself and the services he offers.
 - His activities and services are illegal and dangerous.

- It has come to the attention of our investigation team, as well as Mike Bolhuis, that several ladies have been held captive by Roux.
- He has extorted money and threatened them should they open cases against him at the SAPS.
- We urge any victim who has not yet opened a case against Roux to do so immediately.
- Do not be intimidated by Roux.
- Call SSS or the SAPS immediately.
- We are here to assist and protect you.



IMPORTANT:

If you have not opened a case yet,
please do so
 as soon as possible.

Send the case numbers,
the details of the investigating officers and all
relevant information and proof to us.

We will send it to the appointed, trustworthy
police officers in the centralised task force.

It is important to keep in mind that you might be
threatened or intimidated to NOT open cases and
NOT to send the cases to our organisation -
contact Mr Mike Bolhuis or the SSS Task Team
immediately when this happens.

Wesley Roux intimidates and threatens his victims,
who are too scared to open cases against him.

This is in itself a separate crime for which
he can be prosecuted.

We, therefore, urge the public to send
all information about existing cases against him,
to us for our immediate attention.

DO NOT BE INTIMIDATED

SSS is willing and able to protect and
provide the necessary safety and security.

Remember that we have already posted
numerous project documents as warnings
to the public against Wesley Roux and his associates!
We have a proven track record of
our pursuit to apprehend him.
