- Criminals are terrorising the religious sector, which they view as a soft target.
- Recent news articles have highlighted this increasing trend after the Easter Holidays when several congregations were targeted.
- Since people gather to pray in what they believe is not only a holy space but also a safe space, they are oblivious to the possibility of an armed attack.
 - Bibles are downloaded on smartphones.
 - Credit cards are being used to pay tithes.
 - Vehicles are concentrated in one place during church services.
- Theft and armed robbery quickly escalated into more serious crimes recently, including assault, kidnapping and murder.
- Robbers attend services posing as worshippers before pulling out firearms and robbing congregants of their cell phones and wallets.
- Churches are easy targets because attendees are focused on worshipping, view the buildings as holy, and often tithe in cash.
- However, criminals have proven no qualms about trespassing on holy ground.
- Churches have reportedly started cancelling evening services amid the rise in crime.
- They are turning to private security and CCTV setups.
- Churchgoers are being encouraged to leave their cell phones and purses/wallets at home when attending services.
- Members are also encouraged to tithe via online payments and other digital means.
- Clergy members are being trained in handling firearms to protect their congregants.
