

PROJECT: PERSON OF INTEREST IN A CASE OF THEFT ABU OMER

Abu Omer was identified as a person of interest in a case of theft of high-voltage Lithium solar batteries.

Our SSS specialist investigators request that any person with information on Abu Omer's whereabouts or the location of the stolen batteries contact us.



- BUSINESS ROBBERY AT THE PREMISES OF ELECTRONETIX.
- SAPS CASE NUMBER: SILVERTON CAS 232/03/2024
- THE SOLAR BATTERIES ARE THE PROPERTY OF "JOURNEY 2 GREEN."

THE CASE:

- On Friday, 8 March 2024, at about 23:00, four to six suspects entered the premises of Electronetix, Wapadrand, Pretoria.
- They entered in an Ivico minibus.
- Security guards were assaulted and held hostage at the gate.
- The suspects went to the premises where the containers with solar batteries were kept.
- Containers were ready to be dispatched to a client and closed by welding the doors.

- The suspects opened the containers and loaded 72 Greenrich high-voltage Lithium batteries, 10 Greenrich BMUs, and 2 Greenrich BMAs.
- The suspects then left the premises.
- All batteries do have serial numbers and are registered.
- Once a battery goes online, it can be traced.
- The solar batteries stolen belong to Journey 2 Green.
