 - **Creating Sensationalism:**
 - Manipulated photos are frequently used to create sensational or provocative content that attracts attention and generates engagement on social media platforms.

- This can include creating sensational headlines or captions to accompany manipulated images, further amplifying their impact and reach.
 - Spreading Misinformation:
 - False or sensational posts created through photo manipulation can spread rapidly on social media, reaching a broad audience and perpetuating misinformation.
 - This can have harmful consequences, including shaping public opinion, influencing political discourse, and undermining trust in credible sources of information.
 - Damage to Reputations:
 - Photo manipulation can also be used to tarnish the reputations of individuals or organizations by creating misleading or defamatory images.
 - For example, manipulated photos may depict individuals engaging in unethical or criminal behaviour, leading to reputational damage and public backlash.
